RE: Orthotics Manual: HCPCS Updates to Subchapter 6 and to the MassHealth Orthotics

and Prosthetics Payment and Coverage Guideline Tool

# Introduction

This letter transmits revisions to the service codes in Subchapter 6 of the *Orthotics Manual*. The Centers for Medicare & Medicaid Services (CMS) has revised the Healthcare Common Procedure Coding System (HCPCS) codes for 2025. For dates of service on or after April 1, 2025, you must use the new codes to receive reimbursement. <u>Administrative Bulletin 25-27</u> includes a full description and established rates for the added codes.

The revised Subchapter 6 aligns with the list of service codes in the interactive <u>MassHealth Orthotics and Prosthetics Payment and Coverage Guideline Tool</u>. For prior authorization requirements, service limits, modifiers, and allowable place-of-service codes, providers should refer to the interactive tool. The rate regulation for orthotics services is <u>101 CMR 334.00</u>: *Rates for Prostheses, Prosthetic Devices, and Orthotic devices*.
