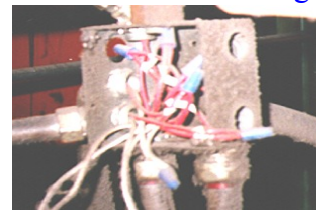


**From Route 93 (South of Boston):**
