**EOS ENTERPRISES INC. D/B/A KATIE'S COUNTRY STORE

Eos Enterprises Inc. d/b/a Katie's Country Store (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, December 17, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Gould's Report.

 3. Copy of License Transfer Application Approval, 6/4/1996;

FACTS

1. On Wednesday, September 4, 2019, at approximately 5:53 p.m., Investigators Kujawski and Gould ("Investigators") conducted an investigation of the business operation of Eos Enterprises Inc. d/b/a Katie's Country Store.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 12-ounce container of Bud Light beer, for one dollar and fifty cents (\$1.50). The underage operative was not asked for identification.


3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1996 with one prior compliance check violation in 2018.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission **suspends the license for one (1) day of which one (1) day will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
