Proceedings

Assistant Secretary Shark called the meeting of the Veteran Advocate Nominating Committee to order at 9:00am. He noted that all votes taken during the meeting would be conducted via roll call vote.

Assistant Secretary Shark summarized that at the last meeting, the Committee conducted 7 first round interviews and will use the time today to narrow down the list to 4 or 5 candidates to bring to the full committee for consideration.

Assistant Secretary Shark declared that for the remainder of the meeting, the preliminary screening committee will enter executive session per Executive Session Purpose #8 to conduct an initial screening of the 29 Veteran Advocate applicants as doing so in an open session will have a detrimental effect on obtaining qualified applicants. He noted that the meeting will adjourn from executive session and the Committee will not reconvene afterwards.

Yote I to approve preliminary screening committee to enter Executive Session: Assistant Secretary Shark called for a vote for the preliminary screening committee to enter executive session. Mr. Dockter introduced the motion, which was seconded by Mr. Farnsworth and approved by roll-call vote (see detailed record of votes above).
