MassHealth Transmittal Letter OXY-32 October 2016

**RE:** Oxygen and Respiratory Therapy Equipment Manual (2016 HCPCS)

This letter transmits revisions to the list of service codes described in Subchapter 6 of the *Oxygen and Respiratory Therapy Equipment Manual*. The Centers for Medicare & Medicaid Services (CMS) has revised the Healthcare Common Procedure Coding System (HCPCS) codes for 2016. The revised Subchapter 6 is effective for dates of service on or after January 1, 2016.

Providers may consult the Centers for Medicare & Medicaid Services (CMS) website at <u>www.cms.gov</u> for a full description of the service codes.

Prior-authorization (PA) requirements, service limits, and place-of-service codes appear in an updated version of the interactive *MassHealth DME and Oxygen Payment and Coverage Guidelines Tool* that has been posted on the MassHealth website. The following service codes have been added to Subchapter 6 of the *Oxygen and Respiratory Therapy Equipment Manual* and also to the *MassHealth DME and Oxygen Payment and Coverage Guidelines Tool.* 

New code **E0465** crosswalks to the following deleted codes: E0450 and E0463. New code **E0466** crosswalks to the following deleted codes: E0460, E0461 and E0464.

## **Claims Issues**

When submitting claims to MassHealth for any item that is paid based on Adjusted Acquisition Cost and that requires PA, the provider must submit the manufacturer's invoice and the quote used for PA purposes. **Reminder:** The manufacturer's invoice may not be altered in any way.
