B. Review of M.G.L. Chapter 112, § 9I and 263 CMR 3.02(2)(b)

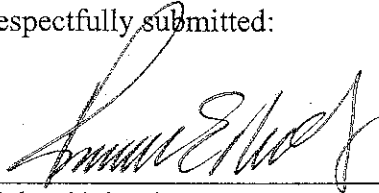
The Board reviewed the statute and regulations requiring a bachelor's degree for licensure as a physician assistant.
