**CALL TO ORDER:** The meeting was called to order at 10:09 a.m. by Jennifer Fraga.

#### **BOARD BUSINESS:**

**2023 Q2 Score Release.** After brief discussion, the report was read and filed.

**CORI Policies.** Board Counsel Lynn Read reviewed the draft revisions of the Agency's CORI Policy for the Board of Public Accountancy. The Board tasked staff to inquire with Agency Management on how to communicate to Applicants on how to report disciplinary action when

applying for licensure. After discussion, a motion was made by Mr. Redmond to accept the draft as policy, seconded by Ms. Parziale. The Motion passed unanimously by a roll call vote.

**EXECUTIVE DIRECTOR'S REPORT:** None separate from items on the Agenda.

**BOARD COUNSEL REPORT:** Board Counsel Lynn Read notified the Board that the Agency is in its final stages of renewing the Contract with NASBA and will report back on its finalization.

#### **DISCUSSION:**

Request for a Board Member to Attend Adjudicatory Hearing October 19-20. The Board was notified of the upcoming Adjudicatory Hearing and was asked if a Board Member would be able to attend. Staff will follow up via email in September 2023.

**UAA Model Rules Implementation Recommendation**. Board Counsel Lynn Read recommended that the Board's regulations will require amendment. Board Counsel will provide guidance at the next meeting on a policy for these upcoming changes.

**Draft Regulations regarding Accreditation and Exam.** Board Counsel Lynn Read will report back to the Board with draft revisions to the regulations over the next few meetings.

Open Session for Topics Not Reasonably Anticipated by the Chair 48 Hours in Advance of Meeting: Chair Richard Grueter notified the Board that the Notice to Schedule for the Business Environment Concepts Exam (BEC) must be taken by Candidates by December 15, 2023. If it is not taken, the Candidate will lose their opportunity.
