MSCPA Peer Review:

Zach Donah, Vice President of Advocacy, Massachusetts Society of CPAs, reported that the Society will be moving its formerly in-house Peer Review function to New England Peer Review, beginning in May 2024. He reported that New England Peer Review performs peer reviews for the state boards in Maine, Rhode Island and Vermon; AICPA will continue to have oversight of these peer reviews; and that AICPA must approve the transfer of this program and may be contacting the Board will questions.
