Board Counsel Lynn Read presented drafted guidance by the Board's recommendation at the August 22, 2024, Board Meeting to address the continuing education questions that were raised during the start of the agency's audit of CPA licensure. During the review and discussion, the Board noted that the draft deserved more information on professional ethics and that the draft should be reviewed at the November 21, 2024, Board Meeting. A MOTION was made by Ms. Parziale to table the draft pending to the November meeting for further review, seconded by Mr. Redmond. The Motion passed unanimously by a roll call vote.
