Draft Regulations: The draft regulations that were reviewed and approved at the August 17, 2023, meeting were reviewed again with the addition of the approved provisions from the Interim Policy on New Uniform CPA Examination and Extension of Credits. During review of the draft, Mr. Grueter suggested that the Board consider internship hours as an item to be covered within the regulations. Board Counsel Lynn Read described the process in which regulations are approved, published by the Secretary of the Commonwealth, and in force. The Board tasked Counsel and Mr. Grueter to define internship hours as well as develop the tools to better understand how they are used currently when applying to sit for the CPA exams.
