Board Meeting Schedule Proposal for 2024. The Board reviewed the meeting schedule for 2024.

BOARD COUNSEL REPORT: None.

DISCUSSION:

Corrected Interim Policy on New Uniform CPA Examination and Extension of Credits: The Board reviewed the unintentional loophole that was discovered in the recently approved Interim Policy on New Uniform Examination and Extension of Credits. A revised draft was presented to the Board which satisfied the time gap (May – December 2023) which deprived an extension of credit that was being granted to all other candidates. Therefore, a MOTION was made by Ms. Parziale to approve the corrected policy, seconded by Ms. Kwan. The Motion passed unanimously by a roll call vote.

Draft Regulations 252 CMR 2.00: The draft regulations that were reviewed and approved at the August 17, 2023, meeting were reviewed again with the addition of the approved provisions from the Interim Policy on New Uniform CPA Examination and Extension of Credits. The Board will incorporate into the regulations the same correction made today to the Interim Policy on New Uniform CPA Examination and Extension of Credits. The Board discussed the significance of internship hours and what defines them. The Board tasked Counsel and Mr. Grueter to define internships and their incorporation into the regulations. Board Counsel will present a new draft once again at the next meeting.

Continuing Education Audits: Executive Director Kerry Cassidy informed the Board that the Agency intends to begin auditing license renewals specific to the continuing education requirements. In doing so, Ms. Cassidy addressed the Board with examples of what licensees are providing as proof of meeting their continuing education requirements. The Board asked that the audit include a request for continuing education certificates. Ms. Cassidy will relay this request to the Agency.

MSCPA Peer Review: Zachary Donah, Deputy CEO of the Massachusetts Society of CPAs, addressed the Board regarding the AICPA's Peer Review Program. The Society also provided their suggestions to the peer review sections within our regulations for consideration. Board Chair Mr. Grueter tasked Board Counsel with a further review of our regulations in relation to peer review.
