# **Board of Public Accountancy Public Meeting Minutes February 20, 2025**

**CALL TO ORDER:** The meeting was called to order at 10:03 a.m. by Executive Director Kerry Cassidy.

#### **BOARD BUSINESS:**

**Public Meeting Minutes of January 16, 2025.** After a brief discussion, Mr. Grueter made a note of a required revision, a MOTION was made by Mr. Redmond to approve the Public Meeting Minutes of January 16, 2025 as amended, seconded by Ms. Parziale. The Motion passed unanimously by a roll call vote.

**OTHER BOARD BUSINESS.** Kerry Cassidy, Executive Director, briefed the Board and meeting attendees that the Division of Occupational Licensure has begun its move to One Federal Street, Boston.

#### **BOARD COUNSEL REPORT:**

Status of Regulations 252 CMR 2.00 Board Counsel Lynn Read stated that the draft regulations have been submitted and are under review with the agency. Ms. Read noted that there are no updates at this time, and she will continue to monitor their progress.

## **Discussion:**

Merger of Continuing Education ("CE") Policies Board Counsel Lynn Read presented the draft merger on CE guidance to the Board. Ms. Read stated that the purpose of the merger was to combine the two CE policies posted on the Board's webpage to provide clear directions for licensees. The Board reviewed the draft and made some minor changes., A MOTION was made by Mr. Redmond to approve the draft merger as amended by the Board, seconded by Ms. Kwan. The Motion passed unanimously by a roll call vote. The draft once finalized will be posted and the two polices on CE will be removed.

Massachusetts Society of CPAs- Legislative update on pathway to becoming a Certified Public Accountant Molly Sullivan, Vice President of Government Affairs, Massachusetts Society of CPAs provided update to the Board on the progress of their legislation for an additional pathway to CPA Licensure. She reported that 23 States have joined their mission and NASBA as well as the AICPA have recently come in support of this pending legislation. Ms. Sullivan said there are no updates from the State House at this time.

Beneficial Ownership Information (BOI) Reporting Requirements update Molly Sullivan once again addressed the Board with an update on the progress surrounding the BOI Requirement. Ms. Sullivan stated that the BOI Requirement is now mandatory, effective March 21, 2025, and enforcement of said requirement is now in effect. Ms. Sullivan mentioned that there is legislation pending in the House of Representatives to extend the deadline to January 1, 2026. Ms. Sullivan will continue to share updates on this item.
