Review/Discuss/Vote for Proposed Regulation Changes Board Counsel Lynn Read presented the proposed regulation changes to 252 CMR 2.00 to the Board as part of a statewide initiative to remove outdated and unnecessary requirements that have become burdensome, and make compliance easier and more cost effective for businesses in the Commonwealth. The Board reviewed and discussed the proposed changes and a MOTION was made by Ms. Parziale, seconded by Mr. Redmond, to approve the proposed changes to 252 CMR 2.00. The Motion passed unanimously by a roll call vote. Ms. Read stated that a Public Hearing on the proposed regulations will be held on August 21, 2025, the same date as a previously scheduled Board Meeting.
