## Mr. Clements:

The relocation fee is to move a "full" container from the drop off point to the desired location. We are charging the customer \$100.00....to drop off the empty container (initial drop off). Then if the customer is moving, say they are moving from Boston to Plymouth, we will charge them a relocation fee to move the full container to their destination. Finally once the container is empty we charge them a final pick up charge that picks up the empty container. As for the application fee, we charge a nominal fee for the paperwork associated with renting them a unit. The need to sign a lease and attached addendums.
