Walnut St. Café Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 16, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators David & Temple's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators David & Temple's Minimum Purchase Age Compliance Check Field Report;
- 2. ABCC Form 43, New License Approval, 12/10/1962;
- 3. Notice of Suspension, 3/12/2001;
- 4. Licensee Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, May 28, 2025, at approximately 7:48 p.m., Investigators David & Temple ("Investigators") conducted a compliance check at Walnut St. Café Inc.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 12-ounce Bud Light beer for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 1962.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
