

FINAL DECISION

I have reviewed the attached Administrative Consent Order with Penalty and Notice of Noncompliance signed on March 4, 2019 by John Steinigan, of Pan Am Railways and Boston and Maine Corporation, and on March 11, 2019 by Michael J. Gorski, Regional Director for the Department (Enforcement Document No. 00006075).

The Department issues this Final Decision incorporating the Administrative Consent Order with Penalty. The Petitioner is ordered to pay a civil administrative penalty of ninety thousand dollars (\$90,000) with a suspended amount of (\$30,000) contingent upon the petitioner's compliance with the terms of the settlement agreement and in accordance with paragraphs 10, 14 and 22 of the Administrative Consent Order. Under the terms of 310 CMR 1.01(8)(c), this proceeding is dismissed with the parties waiving whatever rights they may have to further administrative review before the Department as well as any appeal to court.
