TRAVEL TIME

Time is computed from the time vehicle and helpers report at the original point of loading until the completion of unloading the last load at final destination, less time spent for meals or vehicle breakdown, plus an added charge for each vehicle and all helpers used, to cover running time which shall not be assessed more than once during any one day to the same shipper for the same vehicle as stated below:

Based on the distance between the original point of loading and final point of unloading in accordance with odometer readings:

UP TO AND INCLUDING 10 MILES-----ADD 1/2 HOUR
EACH ADDED 10 MILES OR FRACTION THEREOF-----ADD 1/2 HOUR

DEFINITION - The term "Household Goods and Furniture" as used in this tariff means: The transportation of furniture and household goods in whole or in part incident to a move by a householder to or from a dwelling and a storage warehouse; or from one dwelling to another.

ESTIMATES/QUOTATIONS - Carrier cannot quote a firm price on a move from a residence or establishment to another if a public way has to be used by a vehicle. He may give a written estimate, but in doing so be qualified to estimate within twenty-five (25%) of the actual charges. The final charges to be assessed shall be in accordance with actual tariff rates.


~RATES AND CHARGES

Paulista Moving Inc. is planned on charging on an hourly rate otherwise asked by the client. Paulista Moving Inc. will ask for \$75.00 for the driver and the truck and \$25.00 for each helping man equaling \$100.00. This price will be used from March 1st of every year to December 1st. From December 1st to March 1st our charges will be \$70.00 an hour for both driver and the truck and \$20.00 for each helping man equaling \$90.00 an hour for that time period. Rented trucks will be used and rented as necessary and without extra charge if our trucks are too small or too big for the job. The company will have around \$5,000 at the least in the bank for the emergencies for the truck and the employees. No grand sized pianos will be moved in our company at this time.

Our travel time costs will be as followed. Every 10 miles we will add ½ an hour on the job's total depending on the time the job is being done. So, 20 miles will be \$100 if the job is between March 1st-December 1st or \$50 for each 10 miles meaning \$5.00 per mile. And if the job was between December 1st and March 1st it will be \$90 per 20 miles and/or \$45 per 10 miles meaning \$4.50 per mile.
