**DECISION**

**JAYLEY INC. D/B/A PEABODY PACKAGE STORE  
474 LOWELL STREET  
PEABODY, MA 01960  
LICENSE#: 90766-PK-0956  
VIOLATION DATE: 7/26/2024  
HEARD: 3/4/2025**

Jayley Inc. d/b/a Peabody Package Store (“Licensee”) holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (“ABCC” or “Commission”) held a hearing on Tuesday, March 4, 2025, regarding an alleged violation of M.G.L. Ch. 138 § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 Count). Prior to the commencement of the hearing the Licensee stipulated to the facts in Investigator Bolcome’s report. The hearing record was left open to allow the Licensee to submit photographs. The documents were received, marked as Exhibit A, and the record is now closed.

The following documents are in evidence:

1. Investigative Report of D. Bolcome;
2. ABCC License Authority Certification, New License Approved 4/16/2024;
3. Photograph of Fraudulent Identification;
4. Photograph of Alcoholic Beverages Purchased by Underage Individual;
5. Licensee’s Stipulation of Facts.

**FINDINGS OF FACT**

1. On Friday, July 26, 2024, Investigators David and Bolcome (“Investigators”) conducted surveillance of Jayley Inc. d/b/a Peabody Package Store (“Licensee”) to determine the way its business was being conducted.
2. At approximately 8:30 p.m., Investigators observed a youthful appearing female individual exit the licensed premises in possession of alcoholic beverages, which she placed in a black Nissan Altima. Investigators approached the vehicle, identified themselves and asked to see proof of legal age to purchase alcoholic beverages.


3. Underage #1, actual date of birth 3/25/2005 (age 19) was in possession of one 6-pack of Smirnoff Ice Original which was confiscated by Investigators. She presented to Investigators a fraudulent Connecticut driver's license bearing her name but a different birth date that she used to purchase the alcohol.
4. Investigators then spoke with the clerk on duty, Ramses, and showed him the fraudulent Connecticut driver's license. Ramses admitted to selling Underage #1 the alcoholic beverages.
5. Investigators advised Ramses that a report would be submitted to the Chief Investigator for further review.
6. Jason Hiou, Licensee and Manager of Record, appeared at the Commission hearing and testified that since this incident, out of state identifications are no longer accepted. In addition, Mr. Hiou has added an identification scanner to his point-of-sale system.
7. The Licensee has held a license under M.G.L. c. 138, § 15 since April 16, 2024.

#### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated M.G.L. Ch. 138 § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 Count). Therefore, the Commission **suspends the license for a period of 1 day which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.**
