Section II – Transportation Rates – Time Basis

Transportation rates covering movements of household goods and related articles crated, uncrated or in a container, on a Hourly Basis up to and including 125 miles from origin to destination. Except as otherwise specifically provided for in this tariff, or as amended, the minimum hourly basis will be three (3) hours plus travel time. Regular rates will apply after the first 8 hours of service weekdays (Mon thru Sat). Overtime rates will apply after the first 8 hours of service weekdays (Mon thru Sat and during the first 8 hours on Sunday and Holidays) Double time will apply after the first 8 hours on Sundays and Holidays.

APPLICATION

One truck and Three men (Mon thru Sat) \$125.00 per hour (Overtime \$187.50)
One truck and Two men (Mon thru Sat)\$115.00 per hour (Overtime \$172.50)
Fuel Surcharge on every move (excluding packing services) 10%

Travel Time

An additional charge shall be assessed for each vehicle, helpers or supervisors to cover their Travel Time. Such charge shall not be assessed more than once during any one day to the same shipper for same vehicle, helpers or supervisors. Travel time charge shall be calculate as follows: (See note)

- (a) Up to and including 25 miles from origin to destinationadd 1 hour
- (b) Over 25 miles and up to and including 50 milesadd 2 hours
- (c) Over 50 miles and up to and including 75 milesadd 3 hours
- (d) Over 75 miles and up to and including 100 milesadd 4 hours
- (e) Over 100 miles and up to and including 125 milesadd 5 hours

ADDITIONAL SERVICES – TIME BASIS

Rates and charges for additional Services shown in this Section apply only to movements up to and including 125 miles and are in addition to all other rates and charges.

146 Hoisting or Lowering, where necessary
Where height of building is:
2 stories or less Flat Charge \$80.00 per piece
3 stories Flat Charge \$120.00 per piece
Applies each time service is rendered, Subject to Rule 22.

147 PIANO OR ORGAN HANDLING CHARGE

For Grand Pianos and Pipe Organs \$350.00
For Upright Pianos, Spinets, and other types of Organs \$175.00

Note 1: Applies only once per shipment for each.
Note 2: Will not apply to portable organs, toy organs, or toy pianos.
