## FINAL DECISION

I adopt the Recommended Final Decision of the Presiding Officer. As such I affirm the negative Superseding Determination of Applicability ("SDA") issued on May 29, 2019 by the Southeast Regional Office of the Massachusetts Department of Environmental Protection regarding farm field F2 and reverse the negative SDA with respect to all other fields at the Property. The parties to this proceeding are notified of their right to file a motion for reconsideration of this decision, pursuant to 310 CMR 1.01(14)(d). The motion must be filed with the Case Administrator and served on all parties within seven business days of the postmark date of this decision. A person who has the right to seek judicial review may appeal this decision to the Superior Court pursuant to M.G.L. c. 30A, §14(1). The complaint must be filed in the Court within thirty days of receipt of this decision.
