DECISION

COROMI ENTERPRISES, INC. D/B/A THE COUNTRY STORE 2 NORTH MAIN STREET PETERSHAM, MA 01366 LICENSE#: 90735-PK-0966

Coromi Enterprises, Inc. d/b/a The Country Store ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, July 30, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators McDonough & Temple's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators McDonough & Temple's Minimum Purchase Age Compliance Check Field Report, 4/3/2024;
- 2. ABCC Licensing Authority Certification, Transfer of License Approved, 2/23/2024;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, April 3, 2024, at approximately 5:40 p.m., Investigators McDonough and Temple ("Investigators"), conducted a compliance check at Coromi Enterprises, Inc. d/b/a The Country Store.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one can of Voodoo Ranger beer for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2024 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
