The undersigned hereby petitions this court in the name of the Commonwealth to order, after hearing, that the motor vehicle(s) and/or vessel(s) described above be forfeited to the Commonwealth pursuant to G.L. c. 90, § 24W.

(B) 3 prior assignments/convictions and another pending charge: The respondent has at least three times been so assigned or convicted for such qualifying offenses, and a criminal complaint charging the respondent with a fourth such qualifying offense is presently pending before this court. The undersigned hereby petitions this court in the name of the Commonwealth, upon such an assignment or conviction for such fourth qualifying offense, to order, after hearing, that the motor vehicle(s) and/or vessel(s) described above be forfeited to the Commonwealth pursuant to G.L. c. 90, § 24W.

3. (Check if applicable.) **Additional request for preliminary order to seize and secure.** As detailed in the attached affidavit(s), there are also reasonable grounds to believe that it is necessary to issue a preliminary order to seize and secure such motor vehicle(s) and/or vessel(s) and to provide for their custody during the pendency of this petition.
