- 4. Distance Education Guidelines: Lynn Read, Counsel for the Bureau, explained revisions that had been made to the policy for clarity to external stakeholders and the process for applying for approved schools to apply post state of emergency. MOTION to approve the draft Guidelines for the Use of Distance/Online/Correspondence Tools for Education as written made by Dan Dumont, seconded by Brian Kelly; motion passed by a unanimous roll call vote. (Allan Berry, Dan Dumont, Brian Kelly, Scott King, Pauline Lally, Frank Norton, Sharon Orr, John Viola)
- 5. Discussion of Proposed Revisions to 528 Code Mass. Regs. (CMR) 2.00 and 11.00: Members discussed the draft regulations 528 CMR 2.00 and 11.00, including potential changes to definitions of Pipefitting Welding, Refrigeration Contractor, and Sprinkler Fitter Contractor, as well as requiring applicants for the Sprinkler Fitter Contractor exam to hold a Sprinkler Fitter Journeyman license. Additionally, Karalyn O'Brien, Chair of the Bureau, highlighted that certain sections (but not all) of the existing code required apprentices to perform their work in Massachusetts, which was causing confusion for agency staff in reviewing applications for exam. The Bureau instructed staff to bring these Regulations back for review again at the next meeting.
- 6. Jurisdictional Report by the Office of Public Safety and Inspections
 Inspector Dan Kilburn presented the OPSI jurisdictional report, including inspection results and licensing statistics, to the Bureau members.
