August 16, 2023, 9:30 AM

Ms. Poirier indicated that digital licenses are in effect and are required to be carried at all times. These licenses include pipefitters, refrigeration technicians and sprinkler fitters. Ms. Poirier pointed to a link on the Bureau Website to "View or Print a New, Duplicate or Renewed OPSI License." Before the meeting, Bureau members received an Advisory and Frequently Asked Questions about digital licenses, both of which were posted on the websites for the Bureau and all boards within the Office of Public Safety and Inspections.

8. Jurisdictional report by the Office of Public Safety and Inspections

Dan Kilburn indicated that digital licenses information was distributed at exam sites. In July there were three (3) Pipefitting inspections, and five (5) refrigeration inspections with fines.
