5. Review of Draft Policy on Digital Copy of Licenses

Lynn Read, Bureau Counsel, presented the Draft Policy on Digital Copy of Licenses to the Bureau members for their review. Upon review of the documentation, Brian Kelly inquired whether the policy can also include a photocopy of the physical license as an acceptable method of verification. Bureau Counsel acknowledged Mr. Kelly's suggestion, but stated that management must determine whether the option is acceptable. Motion to approve the draft policy pending the amendment to include a photocopy of the physical license made by John Viola, seconded by Brian Kelly; motion passed by a unanimous roll call vote. (Richard Baldacci, Dan Dumont, Scott King, Justin Fishlin, Allan Berry, Pauline Lally, Frank Norton, Sharon Orr, John Viola, and Brian Kelly.)

6. Board Counsel Report

Lynn Read, Bureau Counsel, presented the following statutory changes to the Bureau members and corresponding changes to the draft definitions under 528 CMR 2.00:

MGL c. 146, § 81:

"Fire protection sprinkler system", a fire sprinkler system, for fire protection purposes, the work of the sprinkler fitter and apprentice shall consist of the installation, service, testing, maintenance and inspection of all fire protection and fire control systems, including both overhead and underground water mains, fire hydrants and hydrant mains, standpipes and hose connections to sprinkler systems, sprinkler tank heaters, air lines and thermal systems, hot water fire protection systems, standpipes connected to sprinkler systems and pumps dedicated for fire protection.

"Work on a fire protection sprinkler system", the on-site layout, on-site fabrication, work and practice concerning the construction, installation, alteration or extension of a fire protection sprinkler system, including the modification, repair, removal and initial acceptance testing and inspection, testing, maintenance and service of a fire protection sprinkler system.

MGL c. 146, § 84:

Section 84. No person shall engage in the business of a master pipefitter, work as a journeyman or apprentice pipefitter, work as a refrigeration technician or work on a fire protection sprinkler system as a fire protection sprinkler system contractor or as a sprinkler fitter or apprentice sprinkler fitter, unless that person is lawfully licensed under section 85 or section 85A.

Justin Fishlin raised concerns over the language not addressing standpipes not connected to sprinkler systems and questioned whether the language could be amended. Bureau Counsel noted that statutory language can be amended only by the Legislature.

Motion to amend the definitions in the draft 528 CMR 2.00 to align with the statutory changes made by Justin Fishlin, seconded by Brian Kelly; motion passed by a unanimous roll call vote. (Richard Baldacci, Dan Dumont, Scott King, Justin Fishlin, Allan Berry, Pauline Lally, Frank Norton, Sharon Orr, John Viola, and Brian Kelly)

7. Jurisdictional Report by the Office of Public Safety and Inspections

Daniel Kilburn presented the OPSI jurisdictional report to the Bureau members. Mr. Kilburn stated that 26 inspections (8 – Pipefitting, 3 – Sprinkler Fitting, 15 – Refrigeration Technician) were performed in the month of December. Four (4) violations were found, in the amount of \$1,250, for unlicensed work and work vans not listing the Refrigeration Contractor's license number.

Mr. Kilburn added that the office performed an analysis of the Bureau exam pass rates and the rates continue to improve.

8. Matters not reasonably anticipated 48 hours in advance of meeting
