Sharon Orr asked if the refrigeration technician board position is to be replaced since Frank Orr and Allan Berry have resigned from their seats. The Chair informed Ms. Orr that she had communicated this information through DOL's leadership team to the Board and Commissions Department. Ms. Orr inquired if seats are filled by statute, Lynn Read confirmed that seats are specified by statute.

6. Jurisdictional report by the Office of Public Safety and Inspections

For the month of August there were five (5) pipefitting inspections resulting in no violations, there were also five (5) sprinkler fitting inspections with 3 violations. DOL also conducted ten (10) refrigeration inspections that resulted in 2 violations.

7. Bureau Counsel

Lynn Read did not have anything to report separate from the Agenda items.

Sharon Orr asked for an update for the regulations that the Bureau passed, Ms. Read indicated that there are no recent updates and that it is not unusual for these types of revisions to take some time.

Justin Fishlin asked Ms. Read about updating code references; he indicated that the code book used is ten years old. Mr. Fishlin inquired on how to update the code book, since in 2016 there was a significant change in the industry for code references. Ms. Read indicated that there are strict rules in updating regulations but that she will look into this request. Mark Fortune reflected on past Bureau meetings and asked John Viola to comment on the building code information that is used. Mr. Viola indicated that there is supposed to be an

update in January 2024 for building codes. Lynn Read will consult in how to apply updates into the codes.
