### **FINAL DECISION**

I have reviewed the attached Administrative Consent Order with Penalty signed by Charles Lehrer of Photofabrication Engineering, Inc., and signed by Mary Jude Pigsley, Regional Director for the Department on September 27, 2017 (Enforcement Document No. 00003228).
