BEAM-W ENTERPRISES, LLC D/B/A A THING OR TWO VARIETY 228 FRANCIS AVENUE PITTSFIELD, MA 01201 LICENSE#: 89784-PK-0974

Beam-W Enterprises, LLC d/b/a A Thing or Two Variety ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, December 5, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Teehan & Gould's Minimum Purchase Age Compliance Check Field Report.

FINDINGS OF FACT

- 1. On Thursday, June 22, 2023, at approximately 6:09 p.m., Investigators Teehan and Gould ("Investigators") conducted a compliance check at Beam-W Enterprises, LLC d/b/a A Thing or Two Variety.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a 24-ounce Twisted Tea malt beverage for two dollars and fifty cents (\$2.50). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2020.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
