APPROVAL OF PREVIOUS MEETING MINUTES

Discussion

Application to Conduct Inspector Continuing Education Classes

Legal counsel presented a draft application for four hour continuing education providers. At the prior meeting, the Board voted to open this provider opportunity to any interested entities but first required a complete application which outlined all the Board's requirements. Counsel reviewed the application and noted that most of its provisions were based upon 248 CMR 11.00 as applicable to licensee continuing education providers. He also directed the Board to a bond requirement, which is required by 248 CMR 11.00 but needed to be set by the Board, he suggested the Board use \$10,000, which is an amount used by other licensing boards. Once approved, Counsel indicated staff will work to distribute the application to interested entities and will process them accordingly.

Vote: A motion was made by WT Motion to approve the application as drafted and seconded by JC

Result: Passed unanimously.

COMMERCIAL PROJECT APPLICATION

VOCATIONAL PROJECT – ASSABET VALLEY RTHS, CITY OF MARLBOROUGH, 860 BOSTON POST ROAD, MARLBOROUGH

Students will rework drainage and vent piping for three bathrooms and two sinks. Students will hang and support garage heaters, this work also includes sizing, hanging, installing and testing the required gas piping.

Petitioner Brian Malone – 860 Boston Post Road, Marlborough – proposes to rearrange fixtures and install water heater. Install Modine heaters. Commercial occupancy. East side waste water treatment system. City owned.

Vote: A motion was made by JC and seconded by WT

Result: Unanimous approval.

VOCATIONAL PROJECT – CAPE COD TECHNICAL HIGH SCHOOL, DREAM DAY CAMP, 165 NANKE-RAFE PATH, BREWSTER

The students will be installing new copper tubing to repair splits, replace shower valves and install a water heater. Students will reattach the L.P. line to the water heater.

Petitioner did not attend the meeting

Vote: Tabled HK motion to table the issue and seconded by BK

Result: passed unanimously

VARIANCES

22-PV-286 FRANKLIN W. OLIN COLLEGE OF ENGINEERING, INC. 1000 OLIN WAY NEEDHAM

The Petitioner (Jeremy Goodman from Franklin w. Olin College of Engineering) is returning with updated plans in and is seeking a variance from 248 CMR, Section 10.10 (18) (i) and (r), to allow the college to convert existing multiuser restrooms designated as men's and women's rooms to gender-neutral restrooms.

Vote: A motion was made by DK and seconded by SB to approve as written.

A no vote by JM JC HK BK WT

Results: Motion denied.

Vote: After further discussion a second motion was made by DK and seconded by WT for one year pilot – one floor of each building changed to gender neutral. Signage as applicant proposed. Enlarged partitions as proposed.

Result: HK, JC, B, voted No WT, DK, SB, JM voted Yes Results: Motion Approved

22-PV-413 MIKE GILLIS, 10 WORLD TRADE CENTER, BOSTON

The Petitioner is seeking relief from, 248 CMR 10.6 Material, to use noncompliant material in the Storm Water System as they are being told 48" perforated PVC is not available.

On the exterior but under overhang, in driveway by loading dock

Vote: A motion was made by WT and seconded by JC

Results: Passed Unanimously

22-PV-440 - CHRIS VENTOLIERE, SOWA POWER STATION, BOSTON

The Petitioner is seeking a variance from 248 CMR, Section 10.10, required fixtures. The current occupancy of 1,080 is based on the availability of 27 public toilets under the restaurant

classification the applicant is asking that the posted occupancy be increased to 1520 without adding fixtures due to the challenges in dealing with the building's structure and historical nature.

Vote: JM Recused HK Chaired

A motion was made WT and seconded by JC to approve the variance as presented.

Result: Passed unanimously

22-PV-444 – ADAM ROBINSON, 14 MYOBER LANE, EDGARTOWN

The Petitioner is seeking a variance from 248 CMR, Section 10.10, required fixtures. The restaurant owner would like to host private events for 30 people, including employees with one unisex, handicap accessible bathroom for patrons and one basement bathroom for employees. They are currently restricted to 20 occupants.

Petitioner did not attend the meeting.

Vote to table: Motion by WT and seconded by HK

Result: Passed unanimously

22-PV-467 - KELO SPA LLC, 1639 CENTER STREET, NEWTON

The Petitioner is seeking a variance from 248 CMR, Section 10.10, required fixtures. The applicant's business model separates genders on different days of the week. Due to genders using the facilities on alternating days they are requesting relief from the requirement to install male and female shower facilities which will allow for the square footage saved to be used for required spa facilities.

Vote: A motion was made by WT and seconded by JC based on only same sex occupancy at any given time.

Result: Passed unanimously

22-PV-477 – BLW ENGINEERS, 34 PICKERING STREET, DANVERS

The Petitioner is seeking a variance from 248 CMR Principal 23, Need for Privacy. The Petitioner seeks permission to install side shields that are 30" deep and 4" off the floor to satisfy the requirements of State Licensing Guidelines for child toilet rooms.

Vote: A motion was made by WT and seconded by RA to approve based on Early

Education Commission Recommendation

Result: Passed unanimously

22-GV-484 – STANLEY CHOW, GILLETTE STADIUM, 1 PATRIOTS PLACE, FOXBOROUGH

The Petitioner is seeking a variance from 248 CMR 5.07-7.1.6 to install natural gas piping below grade without a vented sleeve due to the clear height between the main concourse and club level of approximately 35'-8"

Result: Members noted that no variance would be required, 40 feet of elevated 2 PSI. 4" pipe with no sleeve is what is being proposed.

22-PV-496 – DACON CORPORATION, 20 CREEK BROOK DRIVE, HAVERHILL

The Petitioner is requesting a variance from 248 CMR 10.10Table 1, to reduce the number of showers required from 8 (4 male/4 female) to 4 (2 male/2 female) due to the nature of their manufacturing process and safety standards in place. The facility is primarily used for R&D, engineering and business-related activities. The manufacturing primarily consists of assembly work. Requesting 2 Showers - one male and one female.

VOTE: A motion to approve was made by DC and seconded by WT

Result: Approved unanimously

22-PV-503 – THE KRAFT GROUP, 1 PATRIOT PLACE, FOXBOROUGH

The Petitioner is a variance from, 248 CMR 10.6 Material, to use stainless steel pipe in place of copper for the grey water system in the field tunnel in the North end zone.

Vote: A motion was made to approve the variance with Stainless Steel Victaulic 304 by JC

and seconded by WT

Results: Passed Unanimously

22-PV-512 - ROBYN BIGGS, 66 FREEMAN STREET, UNIT 2, ARLINGTON

The Petitioner is a variance from 248 CMR 3.04, Product Acceptance, to install and handmade, copper bathtub purchased prior to the petitioner being aware of the code requirements.

Vote: A motion was made to approve the variance by RA and seconded by WT

Result: Approved unanimously

WITHDRAWN 22-PV-513 – LYF ARCHITECTS, 55 POND AVENUE, BROOKLINE

The Petitioner is seeking a variance from 248 CMR 10.10, Fixtures, which would require 2 patient and 2 staff bathrooms. Given that the total occupancy is 36 the request is to eliminate 1 bathroom and have a unisex, handicap accessible bathroom for patients which will allow for the practice to utilize the space for patient care. No action taken

22-PV-514 -KUNAL RAO, 10 BOND STREET, WATERTOWN

The Petitioner is seeking variance from 248 CMR 10.10(18)k to reduce the number of bathrooms from 4 to 2. The Petitioner disagrees with the business being classified as medical and states that the space is not large enough to include 4 bathrooms and still offer all the services required to operate as a Restore facility.

Members noted that this is not an appeal, thus the Board would not review how the building was classified. The applicant indicated that they would not be able to expand the space to accommodate the required bathrooms.

Vote: A motion to approve the variance was made by JC and seconded RA

Result: Approved unanimously

22-PV-515 – BLW ENGINEERS, 79 RIVER ROAD, UXBRIDGE

The Petitioner is seeking a variance to install a holding tank for the discharge from a floor drain located in a 12' x 12' shed housing a diesel-fueled, fire pump. The Petitioner states that the premanufactured shed is located 75 feet away from an existing building where the plumbing has been enclosed and 400 feet from the nearest site sewer.

The Petitioner indicated that the non-compliant work already occurred.

Vote: A motion to deny the variance was made by JC and Seconded by WT Result: Unanimously denied – a post installation variance must be applied before the Board can consider the matter.

22-PV-516 -CODE RED CONSULTANTS, 360 CAMPUS CENTER WAY, AMHERST

The Petitioner is requesting a variance from 248 CMR 10.10(18)(b)(1)(b), 248 CMR10.10(18)(i)(1) and 248 CMR 10.10(18): Table 1 to allow occupants of the renovated Goodell Hall to utilize gender-neutral restrooms at Levels 3-6 of the building. Each toilet core will consist of a gang style gender neutral restroom with shared lavatories and toilet compartments enclosed with full height partitions. Additionally, two single-user gender neutral restrooms will be provided.

Vote: RA motion to approve the variance SB seconded

Result: JM voted No. BK, HK, WT, SB, RA and DK voted Yes.

JC Recused

Result: Motion to approve passed.

22-GV-517 – GLYNN MACKENZIE, 104 HARVARD ROAD, SHIRLEY

The Petitioner is planning to eliminate gas service to Building #14 "Food Service" at the MCI-Shirley facility and is seeking a variance to cut and cap the existing 4" plastic low-pressure pipe to that building. The existing service gas piping is plastic Dupont Aldyl-A, installed in the early 1980's, and is no longer approved for use due to its increased risk of failure and leakage. Design documents for the removal of this 4" low pressure Dupont Aldyl-A pipe with instructions for isolating and venting the gas service to the building before cutting and capping with upgraded materials are included.

Vote: A motion was made by WT and seconded by HK to approve the motion with conditions.

Conditions: Approved with a signed, stamped letter from an engineer that using the two materials together is safe. Cap must be as close to the tee as possible.

Results: Unanimously approved with conditions.

22-PV-518 -WICKED PARTNERS, 544 LEGACY PLACE, DEDHAM

The Petitioner disagrees with the classification of the Restore Wellness as a medical facility and requests a variance from 248 CMR 10.10 to reduce the number of bathrooms from 4 to 2 in the

2630 square foot space. The Petitioner states that the space is needed provide all the wellness facilities to sustain a profitable business.

Vote: BK made a motion to approve the variance with the condition that there will be three bathrooms. DK seconded the motion. JC Recused

Result: Unanimously approved on the condition of three bathrooms.

22-PV-519 – INTEGRATED PROJECT SERVICES, 25 NETWORK DRIVE, BURLINGTON

The Petitioner is seeking a variance from 248 CMR 10.10(18)(j) for a pharmaceutical manufacturing facility. The pharmaceutical manufacturing occurs within biological safety cabinets contained in clean rooms. Due to the clean nature of the manufacturing process the Petitioner requests to install 1 shower for each sex immediately outside the clean manufacturing site.

Vote: DK made a motion to approve the variance. SB seconded the motion.

Result: Unanimously approved.
