APPROVAL OF PREVIOUS MEETING MINUTES

Board Meeting Minutes n/a

Discussion

1- Gender-neutral bathroom variance requests.

Board Counsel Kilb requested this discussion regarding the Board's consistency regarding variances seeking multi-user gender-neutral bathrooms, which not referenced in the current plumbing code but are included in the draft code changes. Counsel indicated he was not opining on the merits of any given policy, but was concerned that recent variance requests may render the Board open to accusations of inconsistency. Board members discussed the proposed code changes that are currently under review, and the consensus was that, while not final, these changes should generally be used by the Board when inclined to grant a variance on the subject matter to help the Board be more consistent. In discussion, members noted that some of the proposed changes would likely change, specifically bars on urinals and exemptions for existing installations from installing floor to ceiling partitions. Members agreed this language should be revisited, but they would not seek any changes until a formal public hearing has been held first. No votes taken.

2- Shower Base Product Accepted List

Board members discussed the number of shower bases that appear on the Plumbing Product Accepted Database that are either smaller than the 30" width mandated in the code, or once the base is installed- the interior dimensions is less than 30". The Board members discussed the possibility of removing acceptance of these products, accepting smaller showers, and the liability a plumber would have when installing a shower smaller than 30". No action was taken.

3- 3- PSI Exam Question Review Committee

Board members discussed the on-going effort to review the questions on the journeyman and master plumber exams for accuracy and relevancy. A review group was formed with the Executive Director-Kenneth Peterson, Code Consultant Mike Guida, Board Counsel Charles Kilb and a Board member to be named later. Members were reminded that participation was welcome, though staff noted that there would be restrictions on outside teaching by participants due to examination security.

Vocational School Commercial Project Applications

22-VSP-948 – Diman Regional Vocational Technical High School

Re: Beech Grove Cemetery, 947 Main Road, Westport

The applicant is seeking permission to have students install rough and finish plumbing at the above address for a half-bath and mop sink with hot water supplied via an electric water heater.

Vote: WT to approve, HK seconded Results: Unanimously Approved

Variance Applications

22-GV-949 - Christopher Orefice, 3 Randolph St. Canton

The petitioner for Pappas Rehabilitation Hospital for Children is seeking relief from 248 CMR 3.04, Product, Design, and Testing Standards, to allow the installation of a Heat Recovery Steam Generator that is not on the product accepted list. This is a post-installation variance and state inspector Fred Lima has been notified.

Discussion: Inspector Lima was present. Board members discussed the process of utilizing the exhaust from an 850,000 BTU generator, for heat recovery.

Vote: DK to approve, JW seconded

Results: DK, JW, JM, RA, SB, HK, JC, BK to approve, WT abstained

22-PV-993 – Jeffrey Daignault, 151 Presidents Drive, Amherst

The petitioner for the University of Massachusetts- Amherst is seeking relief from 248 CMR, 10.02, Principle 7, Drainage System of Adequate Size and related policy that requires secondary roof drainage systems terminate, "a maximum of 60" above grade in an area that will be visible to the people who occupy the building." This a post-installation variance and state inspector Jim O'Reilly has been notified.

Discussion: Inspector O'Reilly was present. Board members discussed the roof line and pitch as well as the means to protect the sidewalk area from users. Members decided that a railing system installed along the impacted areas would be sufficient to keep people out and protected.

Vote: WT to approve with conditions regarding railing locations that must be provided to the

22-PV-994 Dan Yerkes, 29 Waterfield Rd, Winchester

The petitioner for the MBTA, per 248 CMR 3.04(2) (a), is seeking relief from 248 CMR, 10.06 (o) PVC Plastic Pipe and Fittings- to allow the installation of PVC for site drainage. The state inspector Taylor Roth has been notified.

Discussion: Inspector Roth was present. Nathan Rae of the MBTA was allowed to present a Power Point presentation on the overall project and the area beneath the walkway where they intend to install PVC for site drainage. The Board discussed the commercial building permit and the necessity to install cast iron plumbing over PVC.

Motion: JW to deny, HK seconded Results: Motion passed 8 to 1

22-PV-995 -Dan Yerkes, 29 Waterfield Rd, Winchester

The petitioner for the MBTA is seeking relief from 248 CMR, 10.02(6)(b). All buildings and structures other than residential dwellings intended for occupancy shall be equipped with sufficient sanitary facilities. The state inspector Taylor Roth has been notified.

Discussion: Inspector Roth was present. The applicant discussed his concerns with safety if a bathroom was installed and that this platform did not have daily personnel working there. Board members noted the issue with the bathroom was not regarding public use but instead for staff, where the Board historically required something for service personnel. It was noted during discussion that there were buildings/structures present on the location and that this was not just an open air platform.

Motion: WT to deny, HK seconded Results: Motion passed 5 to 4 For motion – WT, JW, HK, RA, JM Opposed to motion – JC, BK, SB, DK

225-PV-823 – Dean Fawcett, 85 Research Dr., Hingham

The petitioner is seeking relief from 248 CMR 10.09. Interceptors, Separators, and Holding Tanks, to allow their proposed oil waste collection system. The 10,600 sq. ft. industrial space is being renovated to accommodate up to 8 delivery vehicles to support a shipping and receiving business. Waste from the gas/oil interceptor installed inside the building will be piped to an ejector pump that is pumping to an above-grade, 500- gallon holding tank. This building is served by an on-site Title-5 septic system. The local inspector and board of health have been notified

Discussion: The applicant discussed his interceptor design and the parcel of land, and building it is located on. The Board members noted that because the separator did not connect to a sewer or septic system, no approval was needed.

Results: No Action Taken

22-PV-922 Stephen Kennedy, 17 Hale St., Boston

The petitioner for Boston Trinity Academy is seeking relief from 248 CMR 5.09(1)(22) Installation Instructions, and 248 CMR 3.04 Product Design and Testing Standards to allow the school to perform independent third-party testing of the system, as an alternative method to determine the feasibility and safety- prior to ruling on the variance. The local inspector and board of health have been notified.

On behalf of the petitioner, Tom Iskra and Boston Inspectional Services Department, Sean Lydon, spoke on the original installation and their request to have a third-party testing company evaluate the system. Board members discussed the manufacturer's label, indicating an outdoor unit. It was noted that the applicant was not able to produce a letter from the manufacturer supporting their method of installation. During discussion, the applicant also indicated that they only reason the variance was sought was the cost of removing the non-compliant work, which counsel noted was by code not a valid ground for a post installation variance.

Vote: WT to deny, JW seconded Results: Unanimously denied JM Recused during this agenda item

22-PV-942 John Alcott 229 Parkerville Rd, Southborough

The petitioner is seeking relief from 248 CMR 3.04 Product Design and Testing Standards to allow the installation of a steam shower system that is not on the product accepted list. The local inspector and board of health have been notified.

Discussion: The petitioner spoke of his plans for the steam shower but could not provide documents stating the standards for which the tub and shower valve have been tested. The petitioner was requested to obtain information regarding the standard for the shower, but he indicated that he would not be able to do so.

Vote: WT to deny, JW seconded Results: Unanimously denied

JM absent.

22-PV-976 – Kathleen Zelony 12 Estabrook Park Rd. Westminster

The petitioner is seeking relief from 248 CMR 3.04 Product Design and Testing Standards to allow the installation of a steam shower system that is not on the product accepted list. The local inspector and board of health have been notified.

Discussion: The petitioner discussed their plans for a steam shower system. In this case, the petitioner indicated that the shower was third party tested, but the petitioner lacked the documentation. The petitioner was willing to work on obtaining this information.

Motion: To conditionally approve if the petitioner provides testing documents for the shower valve, to the Board Office.

Vote: WT to approve as outlined, JW seconded

Results: Unanimously approved

JM absent.

22-PV-980 – Fred Prezioso, 1051 Beacon St, Brookline

The Petitioner is seeking a Post Installation Variance from 248 CMR 10.10(18)(i) and 10.10.(18)(k) Employee toilet facilities for (non-industrial) establishments and medical and health care building toilet facilities. The petitioner states that fixtures were replaced in existing exam rooms and bathrooms, the fixtures installed are not ADA compliant. The applicant was told by the local inspector that the fixtures installed need to be ADA compliant. The local board of health and inspector have been notified.

Discussion: The petitioner sought to combine patient and staff bathrooms, but the Board members noted that such a variance is rarely granted. The Board members indicated that they would not be able to address ADA compliance, as that may be the decision of a different jurisdiction.

Vote: WT to deny, JW seconded Results: Unanimously Denied

JM absent.

22-PV-996 – Hillary Hubbard, 485 Arsenal St. Unit Lot 2D

The Petitioner is seeking relief from 248 CMR 10.10(18)(i), to permit this business to have only 2- accessible client restrooms(male and female) and one gender-neutral accessible staff restroom. This is an MRI Diagnostic Imaging business, staffed by 4-technicians with a total occupancy of 9. The local board of health and inspector have been notified.

Vote: WT to approve, RA seconded Results: Unanimously Approved

JM absent.

22-PV-997-Francis Scavone, 488 Pleasant St, Worcester

The Petitioner is seeking a Post Installation Variance from 248 CMR 10.10-18 (i), the applicant is seeking to have one (1) ADA gender-neutral restroom for patients and staff, and there are 2 additional non-ADA restrooms within the space. The local board of health and inspector have been notified. Members noted that they would consider the ADA bathroom the patient bathroom, the non-ADA bathrooms for staff.

Vote: WT to approve, RA seconded Results: Unanimously Approved

JM absent.

22-GV-1022, Greg Bankowski, 11 Old Worcester Rd, Webster

The petitioner is seeking relief from 248 CMR 3.04 Product Design and Testing Standards to allow the installation of a powder coating oven that is not on the product accepted list. This is a post-installation variance and the local inspector and board of health have been notified.

Motion: To conditionally approve provided the petitioner provides an engineered letter to the Board Office stating the oven is safe to use.

Vote: WT to approve as described, DK seconded
