## **Vocational School Commercial Project Applications**

#### 23-VSP-134 Nashoba Valley Technical High School

The applicant is seeking permission to have students install rough and finish plumbing at the school for 10 hair sinks, 2 hand sinks and one laundry. Also, the removal and installation of fixtures in two existing baths, relocate booster pump, and install deluge shower with floor drain and trap primer, and to install a hot water system with tempering valve.

Discussion: Plumbing instructor Chris Ryan answered questions about the details of the student led project.

#### 23-PV-089 John Colbert, 10 Recreation Road, Weston

The petitioner for the MWRA is seeking relief from 248 CMR 10.10 Table 1, Minimum Facilities for Building Occupancy to allow for fewer toilet rooms than the code permits. State Inspector Taylor Roth has been notified.

The applicant clarified that they were seeking one bathroom.

23-PV-132 John Colbert, 90 Redfield Road, Wakefield

The petitioner for the MWRA is seeking relief from 248 CMR 10.10(18)(j) Employee Toilet Facilities for Industrial Buildings to allow for fewer toilet rooms than the code permits. State Inspector Taylor Roth has been notified

The applicant clarified that they were seeking one bathroom.

#### 23-PV-136 Chris Perrotta, 29 Waterfield Road, Winchester

The petitioner for the MBTA is seeking relief from 248 CMR 10.09(1) (a)(1) Interceptors, Separators and Holding Tanks to allow for an alternative method for a gas, oil, and sand separator. State Inspector Taylor Roth has been notified.

Vote: RA to approve, DK seconded Results: Unanimously approved

#### 23-PV-137 Chris Perrotta, 29 Waterfield Road, Winchester

The petitioner for the MBTA is seeking relief from 248 CMR, 3.04(1) Product Design and Testing Standards, to allow for the use of an integral area drain made of Fiberglass Reinforced Polymer (FRP) that is structurally bonded to the station platform. State Inspector Taylor Roth has been notified.

Vote: JC to approve, HK seconded Results: Unanimously approved

#### 23-PV-138 Chris Perrotta, 29 Waterfield Road, Winchester

The petitioner for the MBTA is seeking relief from 248 CMR 10.05(2)c Pitch of Horizontal Drainage Piping to allow for storm pipe drainage at a pitch less than 1/8 inch per foot. State Inspector Taylor Roth has been notified.

Vote: BK to approve, JC seconded Results: Unanimously approved

#### 23-PV-027 Andrew Woodward, 51 Vassar Street, Cambridge

This variance was tabled at the February 1, 2023, Board meeting. The petitioner is seeking relief from 248 CMR 10.10(18) Table 1 to allow for shared, gender-neutral lavatories in lieu of separate men's and women's lavatory facilities within a multi-use commercial space. This is a proposed 174,000 Sq. Ft. facility of eight (8) stories on the campus of MIT to be used for educational, laboratory, assembly, and office spaces. The petitioner is seeking this variance request for 100% of the required fixtures. The local inspector and the Board of Health have been notified.

The applicant indicated that the proposal has been amended to only seek a little more then 20% of the fixtures to be gender neutral. Urinals will be present, but the variance also seeks a gap between the stall floor and ceilings.

Vote: DK to approve, RA seconded

Results: Unanimously approved

WT left the meeting after this agenda item.

#### 23-PV-087 Steven Famolare, 7 Louisburg Square, Boston

The petitioner is seeking relief from 248 CMR, 3.04(1) Product Design and Testing Standards, to allow for the use of a free-standing bathtub that is not on the product accepted list. The local inspector and the Board of Health have been notified.

Vote: DK to approve, JC seconded Results: Unanimously approved

#### 23-PV-088 Kevin Pender, 101 Summit Avenue, Brookline

The petitioner is seeking relief from 248 CMR 3.05, Permits and Inspections, and 10.04 Testing and Safety, to allow for the installation of the main building drain, replaced by another plumber without a pluming permit. This is a post-installation variance. The local inspector and the Board of Health have been notified.

The applicant clarified that the work done was actually performed by an unlicensed business that no longer exists. The applicant indicated the variance was sought to allow the elderly owners to utilize the installation without it being tested or inspected because it was already covered. Legal counsel indicated that granting such a variance would violate the code provisions governing after the fact variances and would be unprecedented. Staff were able to get the Inspector to join the meeting. The inspector and the applicant agreed to take action to inspect the piping, the applicant will be fully responsible for permits and code compliance, therefore, the variance will not be required.

NO ACTION TAKEN

#### 23-PV-093 Timothy Cullen, 42 Perkins Court, Haverhill

The petitioner is seeking relief from 248 CMR 10.10 (7) c (4) Shower Compartments, to allow the use of a 1 ½ drain for a new shower. This is a post-installation variance. The local inspector and the Board of Health have been notified.

#### 23-PV-119 Wellington Farias, 3 North Street, Hopkinton

The petitioner is seeking relief from 248 CMR 10.15 Table 1 and Table 2, Sanitary Drainage System to allow the installation of another bathroom on a 3" building drain. The local inspector and the Board of Health have been notified.

Vote: HK to approve, JC seconded Results: Unanimously approved

#### 23-PV-128 Jim Riley,400-440 Boston Post Road, Wayland

The petitioner is seeking relief from 248 CMR 10.10(18), Minimum Facilitates for Building Occupancy other than Residential to allow the dog day care facility to have just one accessible toilet room. The local inspector and the Board of Health have been notified.

Vote: HK to approve, RA seconded, JC recused

Results: Unanimously approved

#### 23-PV-127 Jennifer Dione, 4263 North Main Street, Fall River

The petitioner is seeking relief from 248 CMR 10.10(18), Minimum Facilitates for Building Occupancy other than Residential, to have one bathroom for both staff and patients. The local inspector and the Board of Health have been notified.

The applicant indicated that had previously been granted the same variance. However, staff researched and indicated that the prior variance was granted for space that was half the size.

Vote: DK to deny, HK seconded, Results: Unanimously approved

#### 23-AID-129

The Board considered the matter of 23-AID-129 – Americo Colaluca, 550 GAR Highway, Somerset

The inspector indicated that the matter was not timely, accordingly the Board heard arguments from both parties as to the timeliness, it did not hear the merits of the matter. The Board did not go into closed session to deliberate.

A motion was made by HK and seconded by JC to dismiss the appeal because it was not submitted in the ten-day period following the inspector's decision, they would not be legally permitted to hear the appeal. A written decision will be sent to the parties.

Staff noted the appellant filed a variance for the same matter, that will be on the next agenda.

#### 23-AID-133

The Board allowed the parties to make presentations regarding there appeal in the matter of 23-AID-133 – Alan Gray, 345 Lincoln Avenue, Amherst

Thereafter, the Board engaged in deliberations in quasi-judicial closed session.

Upon conclusion of deliberations, the Board identified its decision for the record:

Vote: BK voted in favor of the Inspector, seconded by HK., thus denying this appeal.

Results: This appeal was unanimously denied. A written decision will be sent to the parties
