23-VSP-371 Brian Allard, Assabet Valley Regional Technical High School

The applicant is seeking permission to have students remove the old cosmetology sinks and adjust rough-in locations, then install new sinks.

Vote: WT to approve, JW seconded Results: Unanimously Approved

Variance Request

23-PV-377- Jim Pittman, 100 Summit Avenue, Chelsea

The petitioner for the Soldiers' Home in Chelsea, is seeking relief from 248 CMR 10.09 (2)(a) Grease Traps and Interceptors to allow for 11 commercial dishwashers without a grease interceptor. This is a post-installation variance and state investigator Padden has been notified.

Vote: WT to approve, RA seconded

Results: JM, HK, JC, BK, DK, RA, JW, WT to approve, HK abstained

23-PV-220 - Robert Hartwright, 160 Clark Road, Amherst

The petitioner for UMass Amherst is seeking relief from 248 CMR 10.10.(18)(G)(5), Dormitory Toilet Facilities, to change the designation of bathrooms 015, 212A, and 235A to "gender-inclusive". State investigator O'Reilly has been notified.

The applicant indicated that other gender designated bathrooms are on the floor.

Vote: RA to approve, DK seconded Results: Unanimously Approved

23-PV-379- Frank Bushey, 467 Cheshire Road, Pittsfield

The petitioner for the Berkshire House of Corrections is seeking relief from 248 CMR, 3.04(1) Product Design and Testing Standards, to allow for the installation of 56 stainless steel shower enclosures that are not on the product accepted list. State investigator O'Reilly has been notified.

Vote: HK to install one shower enclosure as a test site, with investigator O'Reilly's approval, JW

seconded

Results: Unanimously Approved

23-PV-181- Doug Anderson, 12 Hemenway Street, Boston

The petitioner for the Berklee College of Music is seeking relief from 248 CMR 10.10.(18)(G)(5), Dormitory Toilet Facilities, to allow all single-user toilet facilities to be designated as gender-neutral. The local inspector and the Board of Health have been notified.

During discussion, it was noted that the designation is allowed by right, the applicant indicated that the variance was needed to meet shower requirements which are intended to be met by these single user bathrooms.

Vote: BK to approve, RA seconded Results: Unanimously Approved

23-PV-214- Sam Hathaway, 98 Bishops Forest Drive, Waltham

The petitioner is seeking relief from 248 CMR 10.10 (7) (b)1 Shower Waste Outlet, to allow for the installation of a shower on an existing 1 ½" drain. This is a post-installation variance. The local inspector and the Board of Health have been notified.

The applicant did not appear

Results: Unanimously Approved

23-GV-218- Americo Colaluca, 550 GAR Highway, Somerset

The petitioner is seeking relief from 248 CMR 5.10(17), subsection 10.12.9, Gas Valves Installed for Fire Protection/Suppression Systems, to install a non-mechanical gas valve that serves commercial cooking equipment. The local inspector and the Board of Health have been notified.

This matter was brought to the Board after a appeal was rejected as untimely. The applicant is now seeking a variance based on hardship, not a dispute of the code. Members noted during review that the valve in question was not part of the product accepted system, the applicant must adhere to the code if the system is to be utilized.

Vote: HK to deny, JW seconded Results: Unanimously Approved

23-PV-219- Zachary Rohlfs, 55 Bow Street, Cambridge

The petitioner for Harvard University is seeking relief from 248 CMR 10.15 (10)(a)(2) Sumps and Ejectors, to utilize a sewage ejector pump for one single-user bathroom that is above the height of the building drain. The local inspector and the Board of Health have been notified.

The applicant was not present for this agenda item.

Vote: HK to table, RA seconded Results: Unanimously Approved

23-PV-225- Chris Lennoff, 209 Sargent Road, Brookline (handled at end)

The petitioner is seeking relief from 248 CMR 3.04(1) Product Design and Testing Standards, to allow for the installation of 2 custom concrete lav sinks, that are not on the product accepted list. The local inspector and the Board of Health have been notified.

Vote: HK to approve, WT seconded Results: Unanimously Approved

23-PV-256 - Keith Vermette, 1 Deerfield Street, Billerica

The petitioner is seeking relief from 248 CMR 3.04(1) Product Design and Testing Standards, to allow for the installation of a kitchen sink that is not on the product accepted list. This is a post-installation variance. The local inspector and the Board of Health have been notified.

This sink shall be installed for two years.

Vote: WT to approve, JW seconded Results: Unanimously Approved

23-PV-257- Joshua Bath, 16 Charter Road, Acton

The petitioner for the Acton-Boxborough Administration Building is seeking relief from 248 CMR 10.10 Table 1, and 10.10 (18)r(1), to allow for a reduction in the number of toilet facilities required, and to designate all of them as gender-neutral.

The applicant noted that the bathrooms were all single user, thus the variance was only needed to reduce the fixture count.

Vote: WT to approve, DK seconded Results: Unanimously Approved

23-PV-273- Scott Raimo, 11 Ledgewood Way, Unit 23, Peabody

The petitioner is seeking relief from 248 CMR 10.10 (7) (b)1 Shower Waste Outlet, to allow for the installation of a shower on an existing $1\frac{1}{2}$ " drain. This is a post-installation variance. The local inspector and the Board of Health have been notified.

The applicant indicated that as part of the condo complex, they are unable to get through the floor to install a compliant drain.

Vote: JC to approve, HK seconded Results: Unanimously Approved

23-PV- 327- Michael Moran, 40 Unified Parkway, Sutton

The petitioner is seeking relief from 248 CMR 10.02, Principle 7, Drainage System of Adequate Size and related policy that requires secondary roof drainage systems terminate, "a maximum of 60" above grade in an area that will be visible to the people who occupy the building." This is a pre-installation variance for the new construction of a 352,000 sf manufacturing and warehousing building. The local inspector and the Board of Health have been notified.

A metal canopy was present. The local Inspector is opposed to this variance. Members noted that adherence to basic principles is necessary for safety and system functioning.

Vote: JW to deny, JC seconded Results: Unanimously Approved

23-PV-328- Federico Chiappina, 65 Theodore Drive, Westminster

The petitioner is seeking relief from 248 CMR 10.10 Table 1 and 10.10(18)(j)(4) Employee Toilet Facilities for Industrial Buildings to allow the elimination of all required showers and relief from the required 300' travel distance to toilet facilities. The local inspector and the Board of Health have been notified.

Vote: HK to allow one men's and one women's shower to be installed, and relief from the 300' distance to toilet facilities, WT seconded

Results: Unanimously approved.

23-PV-375- William J. Lynch, 950 Main Street, Worcester

The petitioner for Clark University is seeking relief from 248 CMR 10.10 Table 1, to eliminate all urinals in the building and replace them with toilets. This is a post-installation variance and the local inspector, and the Board of Health have been notified.

The petitioner indicated a desire to not install urinals for flexibility, did not provide a site specific hardship.

Vote: DK to deny, JW seconded

Results: RA, JM, JC, BK, DK, JW, HK in favor; WT/SB opposed

Motion passed 7 to 2

23-PV-376 - Ralph Mulcahy, 20 Newton Street, Brookline

The petitioner for the Dexter Southfield School is seeking relief from 248 CMR 10.10 Table 1, and 10.10(18)(i) to eliminate the code-required showers in their new field house. The local inspector and the Board of Health have been notified.

Vote: HK to approve no showers needed and single user staff bathrooms to be gender neutral,

JW seconded

Results: Unanimously approved

23-PV-378 – Jonathan Cobbeti, 28 Farley Street, Methuen

The petitioner is seeking relief from 248 CMR 10.10 (7)c Shower Compartments to allow the installation of a shower base that does not meet the minimum code requirements. The local inspector and the Board of Health have been notified.

Vote: WT to approve, HK seconded Results: Unanimously Approved

23-PV-380- Paul Graham, 215 Spring St. Florence

The petitioner is seeking relief from 248 CMR:

3.04(1) Board Required Product Acceptance-55-gallon drum sediment filter

10.02 (26) Materials and Design

10.05(15) Connections to Plumbing System Required

10.06 Materials

10.09 Interceptors, Separators and Holding Tanks

The applicant for Crimson and Clover Farms is seeking this relief for the design of their vegetable washroom which has one large trough drain, that drains to daylight on their property. There is one cold-water hose bib used for washing down the vegetables and they utilize no cleaners or chemicals in their process. This is a post-installation variance and the local inspector and the Board of Health have been notified.

Vote: DK to approve, JW seconded

Results: In favor; DK, JW, WT, HK, SB, RA, BK, JC; JM opposed

23-PV-381- Paul Tibets, 251 Harvard Street, Suite 12, Brookline

The petitioner is seeking relief from 248 CMR 3.04(1) Product Design and Testing Standards, to allow for the installation of 2 custom mop sinks that are not on the product accepted list. The local inspector and the Board of Health have been notified.

Vote: HK to approve, JC seconded Results: Unanimously Approved

23-PV-382-Jennifer Ramler, 31 Sea Street, Harwich Port

The petitioner is seeking relief from 248 CMR 10.10 Table 1, to allow a reduced number of toilet facilities required, due to the increase in outdoor seasonal seating. The restaurant currently has two gender-neutral toilet facilities and the applicant is planning to add one more. The applicant states that the septic system is designed for 145 seats. Table 1, 10.10 requires 3 female and 2 male toilet facilities for 145 seats- this total does not include the staff restroom, nor the tenants in an attached apartment. The local inspector and the Board of Health have been notified.
