BOARD OF STATE EXAMINERS OF PLUMBERS AND GASFITTERS SEPTEMBER 2, 2020 DISCUSSION

D1 – Continuing Education Policy (ONLINE TRAINING GUIDELINES) Distance online. No action needed. Future work will take place to consider parameters for permanent allowances

D2 - Governor's Executive Order - Licenses which expire in 2020 are only valid until October 1, 2020. Current Board policy links Continuing Education requirements to the end of the state of emergency, which does not currently have an end date.

There is some confusion from people who believe, because the licenses will expire, they must have the CE done. Policy was adopted in April. As written, the CE extension will last until 90 days after the state of emergency. Legal counsel noted that the state of emergency may continue beyond most other measures, including license extensions, which end on October 1, therefore, people don't need to do the CE classes until the Board changes it. He did not advise the policy change, only that periodic review take place. JM: Leave it the way it is at least until the end of the year. A motion was made to put it on the agenda for January to consider adjustments. DK motion. JC 2^{nd} : Unanimous

The Petitioner (Paul Gibbs) is seeking a variance from 248 CMR, Section 10.10 (18). The variance is for a beer garden located on the Rose Kennedy Greenway in Boston with plans to utilize Condex containers and porta potties. As this is a state project, no Board of Health petition is required.

Discussion: Plans have been updated: Either rent or purchase portable rest rooms. 4 toilets for women and 3 for men. One additional ADA restroom. Fixture counts for rest rooms are in compliance with 10.10 Table 1. Motion: A motion was made by WT to approve this variance requests and seconded by HK. Conditions: Materials shall be in compliance with 248 CMR 10.06 Result: 7 for and 1 against (JC)

TABLED FROM AUGUST 5, 2020 MEETING (WT motioned to table. HK seconded)PV-246 – ACE PRECISION- 1123 SUFFIELD STREET - AGAWAM

The Petitioner (Gregory Neffinger from Greg Neffinger, Architect/NStruct, LLC) is seeking a variance from 248 CMR, Section 10.10 Table 1 to allow the installation of three toilets in the men's room and three toilets in the ladies room. The applicant states there will never be more than 100 people total in this machine shop. The local Board of Health petition has been received.

Result: Application has been withdrawn

PV-29 – MARTHA'S VINEYARD REGIONAL HIGH SCHOOL –OAK BLUFFS

The Petitioner (Christian Huntress from Huntress Associates, Inc.) is seeking a variance from 248 CM, Section 10.10 (18) the renovation of an existing athletic field including an additional 200 bleacher seats without providing rest room facilities. The town of Oak Bluffs will not allow a new connection to their sewer system for field house rest rooms at this time. The town will also not allow a private septic system. The applicant is asking to allow the continued use of school rest rooms which are 560' away until such time the town will allow them to connect into the sewer system. The Oak Bluffs health department has been properly notified.

Discussion: The local plumbing inspector has no objections. New grandstands being constructed. They have a field house that was part of the original plans but are not allowed to connect to a sewer or septic. Joe McNamee: How many fixtures were proposed. 21. They have checked into a tight tank but it is cost prohibitive. 9,000 gallons per month at about \$5,000. Existing grandstands rely on the school restrooms now. Motion: A motion was made by WT to deny this variance requests and seconded by HK. Conditions: None

PV-31 – ACACIA GRILL – 1105 WEST BOYLSTON STREET - WORCESTER

The Petitioner (Penina Gitau from Acacia Grill) is seeking a variance from 248 CMR Section 10.10(18) to allow the continued use of an existing unisex rest room for patrons and staff. The existing rest room is not handicap accessible and there is no room to achieve this as the entire space is only 1,100 square feet. The Worcester Health department has been properly notified.

Discussion: This is under the jurisdiction of the AAB. The size and amount of patrons falls within the Boards allowance under the code for one unisex rest room.

Motion: No motion necessary. This is under the jurisdiction of the AAB Result: No vote taken

SPP-32 – KARAM FINANCIAL GROUP – 1168 HIGHLAND AVENUE, FALL RIVER

The Petitioner (Robert Steven Wilkinson from Wilkinson Associates) is seeking a variance from 248 CMR, Section 10.16 (16) (d) to allow the installation of air admittance valves for 5 kitchen sinks. The petitioner states it would be very difficult to install bow venting for these fixtures. Historical preservation parameters will not allow alterations to the adjacent walls necessary to allow bow venting these sinks. The Fall River Board of health has been properly petitioned.

Discussion: Walls don't go up to the ceiling. Bow venting is really not an option. JM: Never allowed this before.

Motion: A motion was made by HK to deny this variance requests and seconded by WT. *Result*: *Unanimous*

PV-34 – BELMONT MIDDLE & HIGH SCHOOL – 221 CONCORD AVENUE – BELMONT

The Petitioner (Fin Chappell from Architectural Engineers, Inc.) is seeking a variance from 248 CMR Section 10.12 (1) (f) 4. to allow pool water to drain into the building sanitary system. There are concerns a fault in the system discharge could result in contaminated storm water entering the site drainage into Clay Pit Pond leaving the town in violation of the EPA order. The project is a renovation to the existing high school where new plumbing systems are to be installed in the existing pool. The existing pool drainage before renovation was draining to the sanitary system. The local Board of Health has been notified.

Motion: A motion was made by DK to approve this variance requests and seconded by HK. Conditions: Applicant must provide a letter from the municipality stating they are willing to accept the discharge

Result: Unanimous

PV-35 - DCAMM – MASSACHUSETTS COMMUNITY COLLEGES – MULTIPLE CITIES

The petitioner (Paul Peloquin from R.H. White Construction is seeking a variance from 248 CMR, Section 10.14 (5) (l) to allow the use of Onicon turbine flow meters on potable water piping. These meters would be "hot tapped" into the potable water piping. The proposed installations would be at:

Water meters are listed on the website as Product Accepted. The saddle valves are not listed. The main reason they want to do this is cost. HK: Could use pro-press.

GV-35 - DCAMM – MASSACHUSETTS COMMUNITY COLLEGES – MULTIPLE CITIES

The petitioner (Paul Peloquin from R.H. White Construction is seeking a variance from NFPA 54-2012, Section 5.6.8 to allow the use of Onicon turbine flow meters on fuel gas piping. These meters would be "hot tapped" into the fuel gas piping. The proposed installations would be at:

The Petitioner (John Kelly from UMass Memorial Hospital) is seeking a variance from 248 CMR, Section 10.10 Table 1 to allow the installation of one rest room for the public, one rest room for patients and one rest room for staff. The building is 4,000 square feet and serve a maximum of 20 people at any given time. The Marlborough Board of Health has been properly notified.

Discussion: Offsite from the hospital. 4,000 square feet. 3 unisex rest rooms. Patient and public accessible. Staff is not.

Motion: A motion was made by WT to approve this variance requests and seconded by RA.

Conditions: None

Result: Unanimous

PV-37 – DANA FARBER CANCER INSTITUTE –300 BOYLSTON STREET – NEWTON

The Petitioner (Kevin Potter from T.G Gallagher) is seeking a variance from 248 CMR 10.03 Definitions, and 10.14(3)(a)2b, to allow the temperature of exam room and staff hand sinks to be set at 120 degrees. Lavatories for patients and visitors will be tempered to 110 degrees. The Newton Board of health has been properly notified.

Discussion: Out patient clinic consisting of exam rooms. Public lavs will be mixed down to 110. Wants to use 120 at the exam room sinks. Lally: Sinks in exam rooms are accessible to the patients. WT: No action is necessary as they are not technically public restrooms. Result: No action taken

PV-38 NASHOBA VALLEY TECH - 100 LITTLETON ROAD - WESTFORD

The Petitioner (Mark Tocci from Crossfield Engineering, Inc.) is seeking a variance from 248 CMR Section 10.10 Table 1, to allow the removal of 20 existing drinking water stations to protect the students, staff and faculty against the spread of infectious diseases. A hand sink with hands free mixing faucet, hands free soap dispenser and hands free paper towel dispenser will be installed at each of these locations. The goal is to remove the existing water stations before the fall reopening next month the installation of the hand sinks will follow once the materials are procured. The Westford Board of health has been properly notified.

Discussion: Want to use bottled water for the students and eventually go to the bottle filling stations but they are currently unable to get them. They are looking to put in bottle filling stations to replace the existing bubblers but not at the present time.

The Petitioner (David Scholl from Scholl Plumbing) is seeking a variance from 248 CMR 3.04 to allow this installation of two vanity tops with integral sinks which are not Product Accepted. Both faucets are Product Accepted. Specifications for these vanity tops show the tops are tested to the ISO 13006 Encl. G standard for ceramics. The Brookline Board of health has no opposition to this variance request.

Discussion: These sinks have been tested to the proper standard by ISO. The applicant provided the Board with the proper documentation.

Discussion: Two plants that house automatic equipment. Not staffed. No sewer connections there. Fixtures will not get much use. Showers will never be used. Both facilities are in a watershed area. There ais a tight tank at each site and they would like minimal use.

Motion: A motion was made by DK to approve this variance requests and seconded by HK. Result: 7 for and 1 against (WT)

PV-44 – TOWN OF AYER SPECTACLE WATER PLANT – 25 BROOK STREET - AYER

The Petitioner (John Sheehan from CDM Smith) is seeking a variance from 248 CMR, Section 10.10 Table 1 to allow the installation of a single user gender neutral employee rest room with a shower stall in lieu of designated rest rooms. The Ayer Board of health has been properly notified.

Discussion: Unmanned water treatment plant.

Motion: A motion was made by DK to approve this variance requests and seconded by RA. Result: Unanimous

PV-45 -ACTON-BOXBOROUGH REGIONAL HIGH - 156 CARTER ROAD - ACTON

This is a Post-Installation Variance. The previous plumber has been removed from the project.

(A). The Petitioner (Michael Dubuque from Holden Mechanical) is seeking a variance from 248 CMR, Section 10.06 (2) (k) to allow approximately 1,200 feet of Ductile Iron installed underground to remain. This is potable water from the water meter in a pump house to another building with two rest rooms and five safety showers.(B). The petitioner is also asking to allow the safety showers to remain without a circulation loop. The specifying engineer has proposed a flushing program compliant with ANSI Z358.1. The Hopkinton Board of Health has been properly notified.

Discussion: Another company started but was removed from the project.

Motion: A motion was made by DK to grant the variance request to allow approximately 1,200 feet of Ductile Iron installed underground to remain, seconded by JC.

Conditions: None Result: 7 for and 1 against. (BK) Motion: A motion was made by DK to deny the request to allow safety showers to remain without a circulation loop, seconded by JC. Conditions: None Result: Unanimous

The Petitioner is renovating a ¹/₂ bathroom currently piped in with PVC for drain and vent. The request is to leave it as PVC as it has been changed to PVC in the basement which is a considerable way to the main drain.
