## **DECISION**

MARKIRO, INC. D/B/A PLAINVILLE FUEL MART 11 TAUNTON STREET PLAINVILLE, MA 02762

Markiro, Inc. d/b/a Plainville Fuel Mart (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 17, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Gardner's Report.

The following documents are in evidence:

- 1. Investigator Gardner's Compliance Check Field Report;
- 2. Licensee Stipulation of Fact; and
- 3. Copy of Applications Approved 8/14/2014.

## **FACTS**

- 1. On Saturday, July 6, 2019, at approximately 2:54 p.m., Investigators Di Cicco and Gardner ("Investigators") investigated the business of Markiro, Inc. d/b/a Plainville Fuel Mart.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Coors Light beer. The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2014 with no prior violations.
