The Petitioner indicates that this is required due to requirement of the Architectural Access Board via its variance procedure. The Petitioner indicates that there is an existing unisex bathroom located on the second floor. Finally, the Petitioner states that this building was built in 1795 in a historic district and will serve more than 20 patrons (the Petitioner did not provide the number of seats). The hardship is based on space restrictions. The Board of Health was properly petitioned.
