### **VARIANCE REQUEST(S)**

#### PV-175 – NEMA BOSTON – 399 CONGRESS STREET – BOSTON

The Petitioner (Joe Clancy from American Plumbing and Heating) is seeking a variance from 248 CMR 10.10(18) table 1, for the minimum number of required plumbing fixtures for dedicated amenity floor in a newly constructed 21-story high rise residential apartment building. The 21 amenity floor will serve only residence of the apartment complex and their guests. The 21<sup>st</sup> floor will provide 2 single user female toilet rooms (2 female toilets and sinks), 2 single user male toilet rooms (2 male toilets and sinks), 2 drinking fountains, 1 outdoor shower and one indoor shower room. The required fixture amount should be 5 female toilets, 3 male toilets, 2 female lavatories, 2 male lavatories, 1 drinking fountain and 3 showers. The Boston ISD has been notified.

Vote: A motion was made by RA and Seconded by TW to approve the variance request from 248 CMR, Sections 10.10.(18) Table 1, for relief from the total number of required plumbing fixtures for the Level 21 amenity space at the newly constructed NEMA residential apartment building in Boston, as presented in the variance application.

Results: Motion passed (JM recused)

The Petitioner (Randy Bern from Site management Group. Inc.) is seeking a variance from 248 CMR, Section 10.10 (18)(i) 1-4, for relief from the requirement of having two toilet rooms for a new 7,200 sq. ft. airplane hangar. The Petitioner will construct one gender neutral single user accessible toilet room. The local Board of Health has been notified.

Vote: A motion was made by WT and seconded by JC to allow one bathroom with a second bathroom rough plumbed for future use.

Results: Passed unanimously

### GV-177 MIKE CRAWFORD 27 PUDDING STREET - UXBRIDGE

The Petitioner (Paul Messier) is seeking to install a Waterford Tara T-25 LP stove manufactured by FPI. It is a freestanding direct vent stove to be installed in an office as an addition to an existing gas piping system. The stove is believed to have been manufactured approximately 25 years ago. The stove uses a modern millivolt system to provide the pilot and control the glow of gas. The appliance has been converted for use with LP gas.

Vote: A motion was made by WT and seconded by JW to table the application for the petitioner to send the Board engineering reports from the manufacturer. When the reports are received board staff can approve. Results: Motion passed unanimously.

### PV-178 – ETHEL LAVALLEY – 42 FRIENDSHIP STREET – WEST BRIDGEWATER

The Petitioner (David Renzello from HIP Construction, LLC) is seeking a variance from 248 CMR, Section 10.02 (11) to allow the use of an auto vent on a shower stall in a mobile home. The Petitioner is also seeking a variance from 248 CM, Section 10.10 (7) (c) 4 to allow the continued use of an existing shower stall drain in a mobile home. A 2" drain is not accessible, there will only be one 2.5 GPM showerhead and the will be a 6" minimum threshold shower pan installed. The local Board of Health has been notified.

Vote: A motion was made by WT and seconded by JW, to deny the variance requests from 248 CMR, Section 10.02 (11) and 10.10 (7) (c) 4, as presented in the variance application.

Results: Motion passed (JC recused)

### PV-190 – BROAD AND LINCOLN, LLC – 116-118 BROAD STREET - MARLBOROUGH

The Petitioner (Keri DeAlmeida from Brown and Lincoln) is seeking a variance from 248 CMR to put up a wall between two bathrooms so the tenants do not have access to both bathrooms and units. The building has two tenants. On June 30, 2020, one tenant's lease expires and the building will be used for only one business and the business will have use of the two bathrooms. The local Board of health has been notified.

Vote: A motion was made by WT to grant the variance request as presented in the application, to install a wall between the two bathrooms to comply with fixture requirements in 248 CMR 10.10 until the tenant's lease expires on June 30, 2022.

Results: Passed unanimously

### PV-192 - SABRINA COOMBS, DMD - 1034 NORTH MAIN STREET - BROCKTON

The Petitioner (Lewis Colten from Lewis Colten AIA and Associates) is seeking a variance from 248 CMR, Section 10.10.(18)(k). The Petitioner is upgrading and making the existing toilet room accessible for patient use. The Petitioner would like to use the existing facilities that are up one level for staff use. The Board of Health has been notified.

Vote: A motion was made by WT and seconded by JW, to approve the variance request as presented in the variance application.

Results: passed unanimously

### PV-198 – COLEMAN HOUSE - 677 WINCHESTER STREET - NEWTON

The Petitioner (Jenny Budka from Perkins Eastman) is seeking a variance from 248 CMR, Section 10.08 (1) (b) to provide less than 30" clear finished interior in 103 of the 146 showers in the apartment building, measured at the height of the threshold. Showers would have a minimum interior clearance dimension of  $27 \frac{1}{2} \times 57 \frac{1}{2}$  taken at the height of the threshold.

The Petitioner is also seeking relief from 248 CMR, Section 10.10 (7) (c) for the continued use of a 1-1/2" drain in the showers. The local Board of Health has been notified.

*Vote:* A motion was made by JC and seconded by WT, to grant the variance request, as presented in the variance application, to allow 103 of the apartment showers to have a minimum interior clear dimension of  $27 \frac{1}{2} \times 57 \frac{1}{2}$ .

Results: Motion passed (JW opposed, all other members stated yes)

After the vote, the Executive Director noted that through delegated authority the Board office will grant the continued use of a 1-1/2" drain during a tub and shower to shower conversion.

Standard Conditions include:

- A six inch threshold measured from its finished drain to the top of the threshold.
- Shall be equipped with only one shower head with a flow control device that limits the total flow to a maximum of 2.5 G.P.M.

### PV-199 KARIN QUINN – 66 CHESTNUT STREET – WILMINGTON

The Petitioner (John Klesaris from Zork Services, Inc.) is seeking a variance from 248 CMR, Section 3.04(1) for product acceptance. The homeowner purchased and has started restorations on a clawfoot bathtub that was manufactured in 1923. The petitioner will install a product accepted faucet and drain assembly as well as application of a slip resistant surface coating to the bathtub floor that is acceptable to the Board. The local Board of Health has been notified.

Vote: A motion was made by WT and seconded by HK to grant to variance request from 248 CMR, Section 3.04 (1) Product Acceptance, to install a 5 ½ foot clawfoot bathtub manufactured by S.S.M Co., in 1923. The tub will be installed with a product accepted faucet and drain assembly, as well as application of a slip resistant surface coating acceptable to the Board of Examiners of Plumbers and Gas Fitters, as presented in the variance application.

Results: Passed unanimously

# PV-201 – VICTORIA GL LLC d/b/a SUSHI KAPPO – 84-100 PETERBOROUGH STREET (86 PETERBOROUGH) - BOSTON

The Petitioner (Elizabeth Lashway from Lashway Law LLC) is seeking a variance from 248 CMR, Section 10.10(18)(b)(2) (c) to use a small patio for seating up to 10 increasing the capacity to 29 people (19 inside and 10 outside) and to not add another bathroom due to the size of the restaurant. The restaurant has 800 sq. ft. of dining /cooking space on the first floor. The storage space in the basement has another 800 sq.ft. and the patio consists of 275 sq. ft. There is currently 1 unisex bathroom used for both patrons and employees. Boston ISD issued a building code refusal letter in response to Sushi Kappo's application for a use of premises permit for the patio as Plumbing variance is needed.

Motion 1: A motion to deny was made by JW, this motion was not seconded.

Motion 2: A motion was made by DS and seconded by TW to grant the variance request from 248 CMR, Section 10.10(18)(b)(2)(c), with the condition of a time variance for 1 year from the date of the March 3, 2021, Board of State Examiners of Plumbers and Gas Fitters meeting, to become compliant with 248CMR. Results: Motion passed (JM recused, JW against, all other members voted yes)

# PV-159 ATF ATHLETIC ALEXI TUNRPIKE ST, UNITS 8 – 11, 290 TURNPIKE STREET SOUTH EASTON

The Petitioner (Jeffrey Metcalfe) is seeking a variance from 284 CMR, Section 10.10 Table 1, to provide 2 HP bathrooms (1 per gender) with a toilet and sink. The Petitioner will provide 1 uni-sex HP shower. The employees will use 1 of the new HP bathrooms. The fitness classes do not exceed 2-12 people and there are three employees that do not work the same shifts together. The tenant space consists of 7,200 sq. ft. and is

considered a business use group for commercial recreation – indoors. The local Board of Health has been notified.

### Discussion:

Vote: A motion was made by JC and seconded by WT to grant the variance request from 248 CMR, Section 10.10 (6)(b) as presented in the variance application dated February 22, 2021, to allow one accessible bathroom per gender (2 total) with a toilet and sink and to provide one gender-neutral accessible shower. Results: Motion passed unanimously.

# PV-160 SOUTH SHORE BASEBALL ACADEMY, UNITS 3-7, 290 TURNPIKE STREET SOUTH EASTON

The Petitioner (Jeffrey Metcalfe) is seeking a variance from 248 CMR, Section 10.10 Table 1, to provide 2 HP bathrooms (1 per gender) with a toilet and sink. The Petitioner will provide 1 uni-sex HP shower. There is 1 employee who will use 1 of the new bathrooms. The tenant space consists of 8,896 sq.ft. and is considered a business use group for training and skill development. The class size will not exceed 10-12 students. The local Board of Health has been notified.

Vote: A motion was made by JC and seconded by WT to grant the variance request from 248 CMR, Section 10.10 (6)(b) as presented in the variance application dated February 22, 2021, to allow one accessible bathroom per gender (2 total) with a toilet and sink and to provide one gender-neutral accessible shower. Results: Motion passed unanimously.

### PV-204 CITY OF FALL RIVER COMMUNITY UTILITIES - 700 WILSON ROAD - FALL RIVER

The Petitioner Edward Whatley) is seeking a variance from 248 CMR, Section 10, for the City's unmanned utility structure be exempt from 248 CMR. The Petitioner is also seeking relief from 248 CMR 10.10 (18) to install a single user 521 CMR compliant gender neutral restroom.

The City of Fall River Department of Community Utilities is replacing an unmanned sewer pump station at 700 Wilson Road. The electrical and control equipment will be enclosed in a generator building to prevent weather-related damage. This building is not intended for human occupancy and the building's sole purpose is to provide weather protection. Community Utilities requested a determination from the Plumbing Inspector that unmanned assets of this type should not be subject to the plumbing code. The plumbing inspector stated that a variance would be required from the State Plumbing Board, but he had no issues with the variance request. The Board of Health agreed with the plumbing inspector. Upon questioning, the applicant indicated individuals would periodically work in the building but the nearest bathroom was more than a mile away.

Vote: A motion was made by TW and seconded by JC voted to deny the variance request from 248 CMR, Section 10 Principles 1 and 3 and section 10.02 (6)(b) as presented in the variance application. The Board members noted that the applicant only mentioned cost but did not provide evidence to find a hardship or unusual circumstance to support the request for a variance.

Results: Motion passed unanimously
