#### **VARIANCE REQUEST(S)**

#### PV-207 MILFORD WATER COMPANY – 14 SOUTH CEDAR STREET – MILFORD

The Petitioner (Matthew Morganelli from Tata and Howard, Inc) is seeking a variance from 248 CMR 10 (18), to not install a bathroom in the Godfrey Brook WTP. The location does not have an available sewer to tie into for sanitary waste disposal. The local Board of Health has been notified.

Vote: A motion was made by JC and seconded by JW to deny the variance request from 248 CMR Section 10(18). The Board determined that there was insufficient evidence to support the request for a variance.

Result: Motion passed unanimously.

## BOARD OF STATE EXAMINERS OF PLUMBERS AND GASFITTERS APRIL 7, 2021 PV-208 WEYMOUTH BROOKPOINT – 50 COMMERCIAL STREET – WEYMOUTH

The Petitioner (John Del Tufo of Wozny / Barbara and Associates) is seeking a variance from 248 CMR 10.09, Inceptors, Separators and Hold Tanks, to allow the surface area below the building overhang to be conveyed through the separator and discharge to the storm system. The local Board of Health has been notified.

Vote: A motion was made by JC and seconded by TW to grant the variance request from 248 CMR, Section 10.09 Inceptors, Separators and Hold Tanks, on the condition that the Board receives correspondence from the Department of Environmental Protection approving the discharge going to the storm system through the

#### PV-209 DRUGHELP - 560 LINCOLN STREET - WORCESTER

The Petitioner (Kelly Knopp of Commercial Construction Consulting) is seeking a variance from 248 CMR 10.10(18)(k)(i), to not provide separate male and female facilities for patients/visitors. The Petitioner proposes one gender neutral toilet room for staff and one gender neutral toilet room for patients. The local Board of Health has been notified.

Vote: A motion was made by RA and seconded by HK grant the variance request from 248 CMR, Section 10.10(18)(k)(1), for this project, to not provide separate male and female facilities for patients/visitors. There will be one gender neutral toilet room for staff and one gender neutral toilet room for patients.

Result: Passed unanimously

## PV-215 MASSACHUSETTS BAY TRANSPORTATION AUTHORITY – 300 MAIN STREET-CAMBRIDGE

The Petitioner (Chris Curran from AHA Engineers) is seeking a variance from 248 CMR 10.10 Table 1 — minimum facilities for building occupancy, to not provide two public restrooms and a separate employee restroom. The Petitioner proposed one single accessible employee restroom and one accessible gender-neutral restroom available to the public at the platform level the expanded subway station. This is a state project, local Board of Health notification is not required.

Vote: A motion was made by TW and seconded by RA grant variance request from 248 CMR, Section 10.10 Table 1, for this project, to install one gender neutral, accessible restroom at the platform level of the expanded subway station for public use.

Result: Passed unanimously

## PV-219 MASSACHUSETTS WATER RESOURCES AUTHORITY BRAINTREE-WEYMOUTH PUMP STATION - 27 KILBY STREET - QUINCY

The Petitioner (John Colbert from MWRA) is seeking a variance from 248 CMR 10.10(18)j, to not add additional restrooms in the Upper Screenings, Pump Access and Loading portions of the building. The MWRA is planning to replace exiting screening and odor control equipment and construct a building addition to house the expanded odor control system. The public does not have access to the facility grounds and the employees use facilities in the same building that are within 300 ft. This is a state project, local Board of health petition is not required. This is a state project, the local Board of health petition is not required.

Vote: A motion was made by TW and seconded by JC to grant the variance request from 248 CMR 10.10(18)j

Result: Passed unanimously

## PV-220 MASS WATER RESOURCE AUTHORITY LEINGTON STREET PUMP STATION – 34 LEXINGTON STREET - WALTHAM

The Petitioner (John Colbert from MWRA) is seeking a variance from 248 CMR 10.10 Table 1, to not add a shower at the pump station. The Authority is proposing to replace the existing roof. The plumbing work associated with the roof replacement includes demolition and replacement of 4 inch roof drains attached to an

existing rain leader. The station is not occupied or open to the public. The employees use facilities at the MWRA Chelsea facility. This is a state project, the local Board of health petition is not required. *Discussion:* 

Vote: A motion was made by JC and seconded by TW grant the variance request from 248 CMR, Section 10.10 Table 1, for this project, to not construct a shower at the Lexington Street Pump Station.

Result: Passed unanimously

## PV-221 MASS WATER RESORCE AUTHORITY BELMONT PUMP STATION – 41 ALEXANDER AVENUE - BELMONT

The Petitioner (John Colbert from MWRA) is seeking a variance from 248 CMR 10.10 Table 1, to not add a shower at the pump station. The station is not open to the public and the employees use facilities at the Chelsea facility. The Authority is proposing to replace the existing roof. Plumbing work associated with the roof replacement consist of the demolition and replacement of existing 4 inch by 9 inch scupper drains at the parapet wall which is attached to a 4 inch by 3 inch downspout. The sanitary sewer vent will be extended to comply with 238 CMR. This is a state project local Board of health petition is not required.

Vote: A motion was made by WT and seconded by JC to grant the variance request from 248 CMR, Section 10.10 Table 1 for this project, to not add a shower at the Belmont Pump Station.

Result: Passed unanimously

#### PV-223 NOVA COLDSTORE CORP. 425 CONSTITUTION DRIVE TAUNTON

The Petitioner (Marc Carnicelli from CMC Design Build) is seeking a variance from 248 CMR 10.10.J.4, for a proposed addition in a freezer warehouse that will be more than 300' from the toilet room. The Local Board of Health has been notified.

Motion: A motion was made by WT and seconded by JC to approve the variance request from 248 CMR, Section 10.10.J.4, to allow more than 300'from the toilet room in the proposed addition in the freezer warehouse.

Result: passed unanimously

#### PV-224 CITY OF GREENFIELD FIRE DEPT. - 412 MAIN STREET - GREENFIELD

The Petitioner (Steven Chevalier from the City of Greenfield) is seeking a variance from 248 CMR, Section 10.06, to use ABS plastic wherever practicable and make transitions to cast iron where they are needed. In 2-3 years the apparatus bays and temp double wide trailers are going to be removed and all the materials will become waste. The local Board of Health has been notified.

Vote: A motion was made by WT and seconded by JW, to deny the variance request from 248 CMR Section 10.06, to use ABS plastic. The Board determined that there was insufficient evidence to support the request for a variance.

Result: Passed unanimously

#### PV-237 COUNTY OF PLYMOUTH 4-H 54 OBERY STREET – PLYMOUTH

The Petitioner (Francis Balser from the County of Plymouth) is seeking a variance from 248 CMR, Section 10.10, to not install a bathroom in a 21' x 36' plastic shelled greenhouse that is used for children's 4-H programs. There is access to a bathroom approximately 75' away in a county owned administration /office building. This is a state project local Board of health petition is not required.

Vote: A motion was made by WT and seconded by JW to grant the variance request from 248 CMR, to not install a bathroom in a 21'x 36' plastic shelled greenhouse as long as there is access to a bathroom approximately 75' away.

Result: Passed unanimously

#### PV-238 DENTIST OFFICE - 1218 HANCOCK STREET - QUINCY

The Petitioner (Leo Martin from Martin Realty Management) is seeking a variance from 248 CMR, 10.10.18(k) medical and health care building toilet facilities. The Petitioner is interested in renting space in a 4 story office building for a dentist office. The floor where the dentist office will be located does not have bathroom facilities. There are bathrooms on the lower level and upper levels that the public can use. The local Board of Health has *Vote: The applicant failed to appear. A motion was made by JW and seconded by TW to table the variance application.* 

Result: Passed unanimously

#### PV-239 TOWN LINE NOMINEE TRUST – 137 HOLMES ROAD – EASTHAM

The Petitioner (Alexander Hay from Wellfleet Shellfish Co.) is seeking a variance from 248 CMR, Sections 10.06 and 10.00, to install PVC drain and vent piping for a shellfish processing plant. The cast iron drain pipes have failed and are no longer working properly and will be replaced. The request also includes new floor drain piping and drain and vent piping for the new processing station being built within the plant. The amount of salt water and acidity from the salt air is causing the cast iron piping to fail at an accelerated rate. The local Board of Health has been notified.

Vote: Members noted that there were code compliant materials that could be used. A motion was made by WT and seconded by HK, to deny the variance request from 248 CMR, for the use of PVC piping. Board approved materials need to be used.

Result: Motion passed (JW abstained)

#### PV-251-PROPOSED PET SUPPLIES PLUS- 256 NORTH MAIN STREET – NORTH READING

The Petitioner (Benjamin Barry from Fabo Architecture, Inc.) is seeking a variance from 248 CMR, Section 10.10 for the number of required plumbing fixtures in a renovation of an existing space for a pet store. The local Board of Health has been notified.

Discussion:

Vote: HK motioned to deny the variance request and seconded by JW. Needs two single user restrooms for employees only. Fire egress fixture count should not be used.

Result: Passed unanimously

#### PV-252 - PROPOSED PET SUPPLIES PLUS - 356 COOLEY STREET - SPRINGFIELD

The Petitioner (Benjamin Barry from Fabo Architecture, Inc.) is seeking a variance from 248 CMR, Section 10.10 for the number of required plumbing fixtures in a renovation of an existing space for a pet store. The local Board of Health has been notified.

Vote: A motion was made by WT and seconded by HK take no action on the variance request from 248 CMR, Section 10.10, for this project, as more than two restrooms are not required.

Result: Passed unanimously

#### PV-255 - PRAMOD GUPTA - 8 BOBCAT HILL LANE - ASHLAND

The Petitioner (Pramod Gupta) is seeking a variance from 248 CMR, to allow the connection of two new bathrooms to a 3" sewer pipe as the 4" main is inaccessible due to a finished basement.

Vote: A motion was made by WT and seconded by JC, to allow two additional bathrooms to connect to an existing 3" sewer line for a total of four bathrooms connecting to a 3" sewer line.

Result: Passed unanimously

Legal counsel explained that the chair was not aware of two variance requests and they were not on the agenda due to an internal error error. He explained that the applicants were invited. In general, this item should only be used for emergencies and non-controversial issues and that absent this, applicants would be advised to wait for the next meeting. Counsel advised the Board to table if the matters were controversial.

#### PV-218 MERIEL MARINA BAY – 552 VICTORY ROAD QUINCY

The Petitioner (James Southwood from Break rock Brewing) is seeking a variance request from 248 CMR, Section 10.10, Table 1, from the requirement to install a shower in planned light industrial space.

Vote: A motion was made by HK and seconded by JW to grant the variance request from 248 CMR, Section 10.10 Table 1, with the use of an emergency shower.

Result: Passed unanimously

## PV-222 DEPT. OF CONSERVATION AND RECRATION-505 HILLSIDE STREET – STABLE – MILTON

The Petitioner (George Hu from Air Water Energy Engineers) is seeking a variance request from 248 CMR, Section 10.06(o), for approval to use PVC pipes for the drains that collect horse urine.

Vote: A motion was made by JC to partially approve the variance request from 248 CMR, Section 10.06(o), for this project, PVC was not allowed but it could utilize polypropylene or coated cast iron pipes.

Result: Passed unanimously
