DECISION

NANCY R. MCNICHOLAS D/B/A PLAZA PACKAGE 115 SAMOSET STREET PLYMOUTH, MA 02361 LICENSE#: 89541-PK-0984

Nancy R. McNicholas d/b/a Plaza Package (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 17, 2024, regarding an alleged violation of M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age (1 count). Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator David's Report.

The following documents are in evidence:

- 1. Investigator David's Report;
- 2. ABCC Approval Cover Sheet, Transfer of License Approved 4/12/2019;
- 3. Licensee Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Saturday, May 25, 2024, at approximately 7:40 p.m., Investigators Teehan and David ("Investigators"), conducted surveillance of Nancy R. McNicholas d/b/a Plaza Package ("Licensee") to determine the way its business was being conducted.
- 2. Investigators observed a motor vehicle parked in front of the establishment. A youthful appearing male driver exited the vehicle and entered the licensed premises.
- 3. Shortly thereafter, the male exited the licensed premises in possession of alcoholic beverages: one 375 milliliter bottle of Smirnoff vodka, one 12-pack cans of Busch Light beer and one 6-pack bottles of Corona beer.
- 4. Investigators approached the vehicle, identified themselves and asked to see proof of legal age to purchase and/or possess alcoholic beverages.

- 5. The male, Underage #1, actual date of birth 6/23/2006 (age 18), stated to Investigators that he was not asked for any identification to purchase the alcohol.
- 6. At approximately 9:20 p.m. Investigators entered the licensed premises and spoke to the clerk about the violation. The clerk stated he did not ask Underage #1 for any identification as he had seen his identification in the past.
- 7. Investigators informed the clerk of the violation and that a report would be filed with the Chief Investigator for further action.
- 8. Nancy McNicholas, Licensee, appeared at the Commission hearing.
- 9. The Licensee has held a license under M.G.L. c. 138, § 15 since 2019 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age (1 count). Therefore, the Commission suspends the license for one (1) day which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.
