Upland Sportsman's Club Inc. (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, March 8, 2011, regarding an alleged violation of 204 CMR 2.05 (1). Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Michael Teehan's report.

The following documents are in evidence:

- 1. Licensee's Stipulation of Facts;
- 2. Investigator Michael Teehan's Report dated November 10, 2010;
- 3. Points to Dollars Conversion Chart; and
- 4. Photocopy of Pull Tab Gaming Tickets.

A. Mitigation Packet including a Letter of Support by the Board of Selectman, the Chief of Police, and Documentation of Charitable Activities.

<u>FACTS</u>

- 1. On Friday October 22, 2010, Commission Investigators Kenny and Teehan observed the business operation of the Upland Sportsman Club, Inc.
- 2. Upon entering the bar, the investigators noticed seven (7) poker machines on the licensed premises.
- 3. The investigators observed a conversion chart in plain view.
- 4. The manager of record told the investigators the club paid off for winning on the electronic video devices.
- 5. The investigators also observed pull-tabs that were not issued by the Massachusetts State Lottery
- 6. The manager of record testified to the Commission that the machines were removed from the premises.
- 7. Administrative review of the file indicates this was the first violation by the licensee in fifty-four (54) years of existence.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (1). As the licensee has been in business for fifty-four (54) years and had no previous violations, the Commission issues a **WARNING**.
