#### • Deputy Commissioner of Boards, Esther Laine report to the board:

Executive Director Thomas Burke reported the CME approval update to the Board. Read and filed.

# • Board counsel, Sheila York's report to the board:

- i. Attorney York reported that that the Department of Public Health ("DPH") has issued a policy implementing updates to G.L. c. 111, s. 228, which require that certain health care practitioners notify patients how much the patient will pay for planned hospital stays, medical procedures, health care services, and referrals based on the patient's specific health insurance plan. Podiatrists are currently not subject to these new statutory requirements. However, they should be aware of these new requirements that may impact processes within the medical settings where the podiatrist works.
- ii. Attorney York stated that the Board was recently asked whether a podiatrist must provide written notification to patients before the podiatrist leaves a practice. The regulations do not require written notification to a patient when a podiatrist leaves or retires from a practice. However, the podiatrist must ensure that patient records will be maintained in compliance with Board regulations. Podiatrists who leave their practice should notify their patients that they are leaving the practice and provide guidance on how the patient can find other providers in the area.
- iii. Attorney York notified the Board that the proposed FY22 supplemental budget, H. 4345, would extended authorization for remote public meetings until July 15, 2022. This authorization was previously set to expire on March 31, 2022. If the authority to meet remotely is extended, the Board would still be able to choose to meet in person.
