



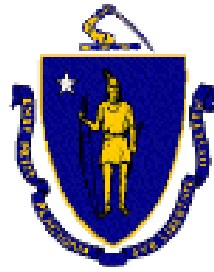

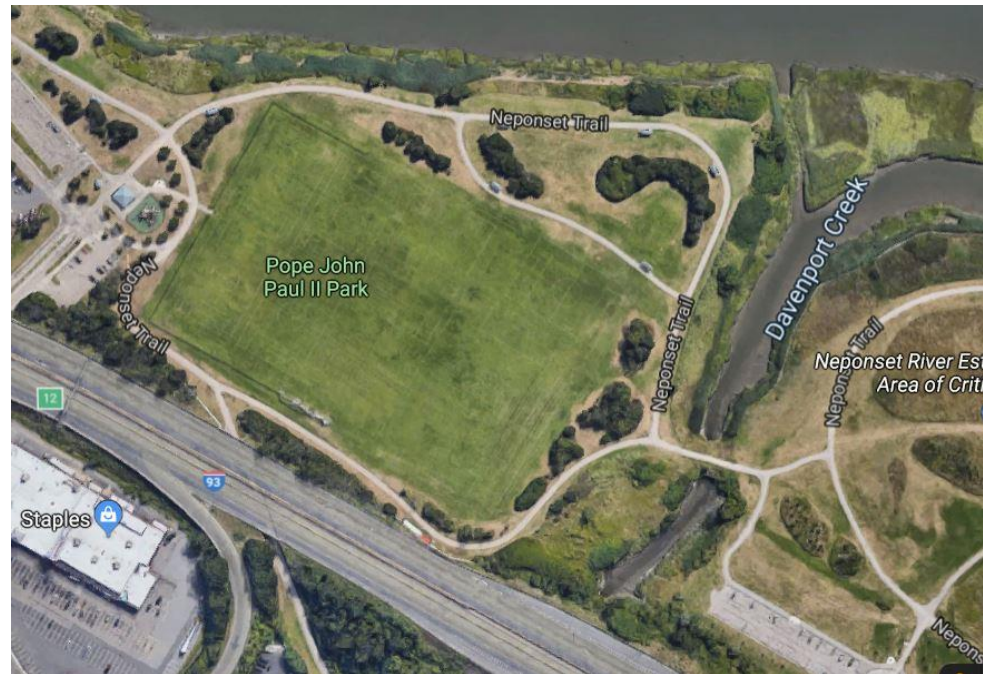

Project Context

- Existing playground is being demolished.
- The playground area is being slightly enlarged.
- New playground equipment, fencing and poured-in-place rubber surfacing will be constructed.
- Fitness equipment will be added in the park.

- Existing equipment cannot be renovated.
- Demolition to be completed by December 2019.

Scope

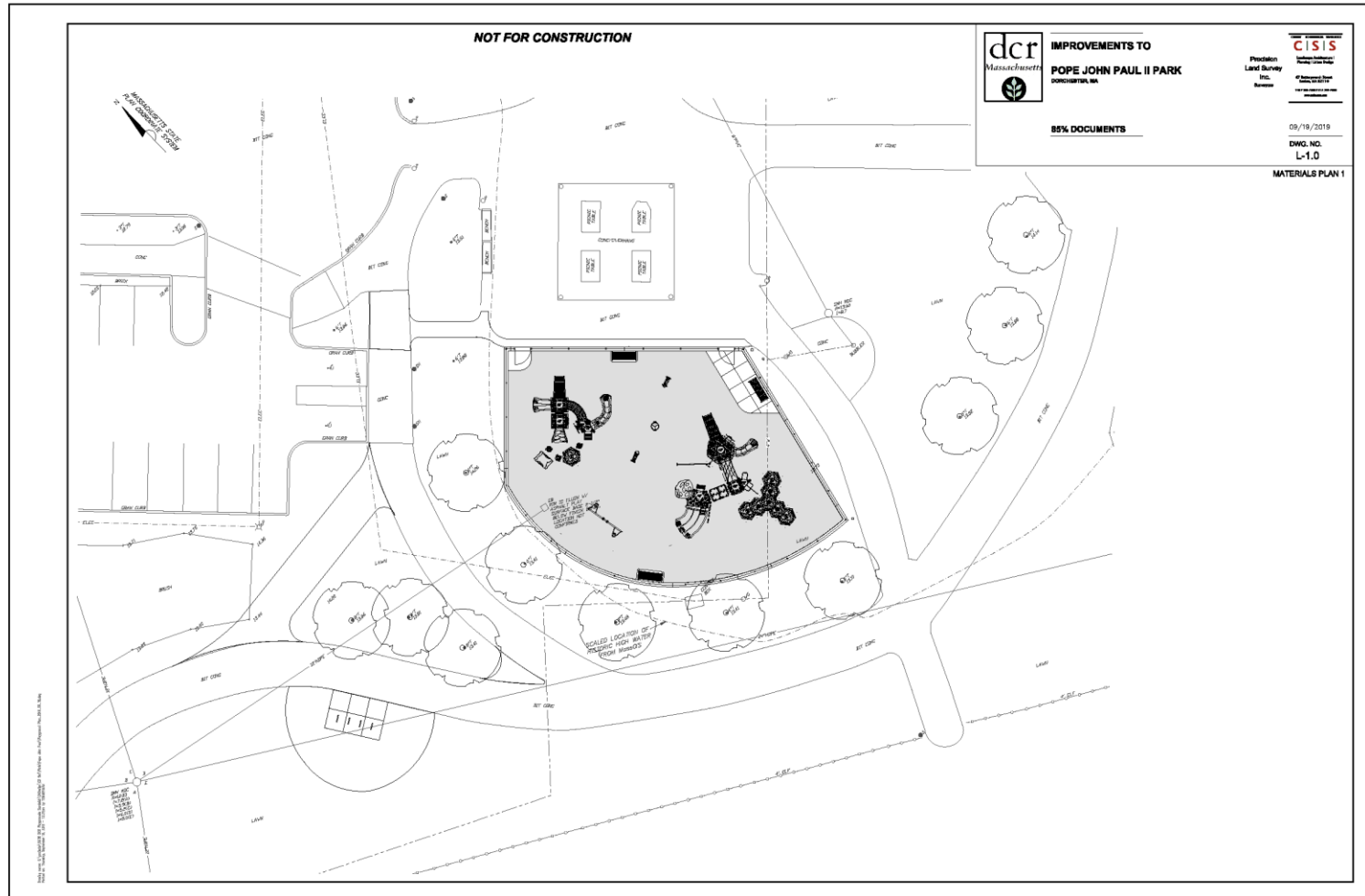
- Install new play equipment and play surfacing for 2-5 and 5-12 year-olds
- Install new 42-inch fencing
- Add 2 secure playground entrances (latch-able gate)
- Install new benches
- Restore landscape
- Install new fitness equipment and surfacing.

Design considerations

- Play value for different age groups
- Volume of visitation
- Accessibility
- Grades and construction details
- Maintenance.

2-5 year-olds

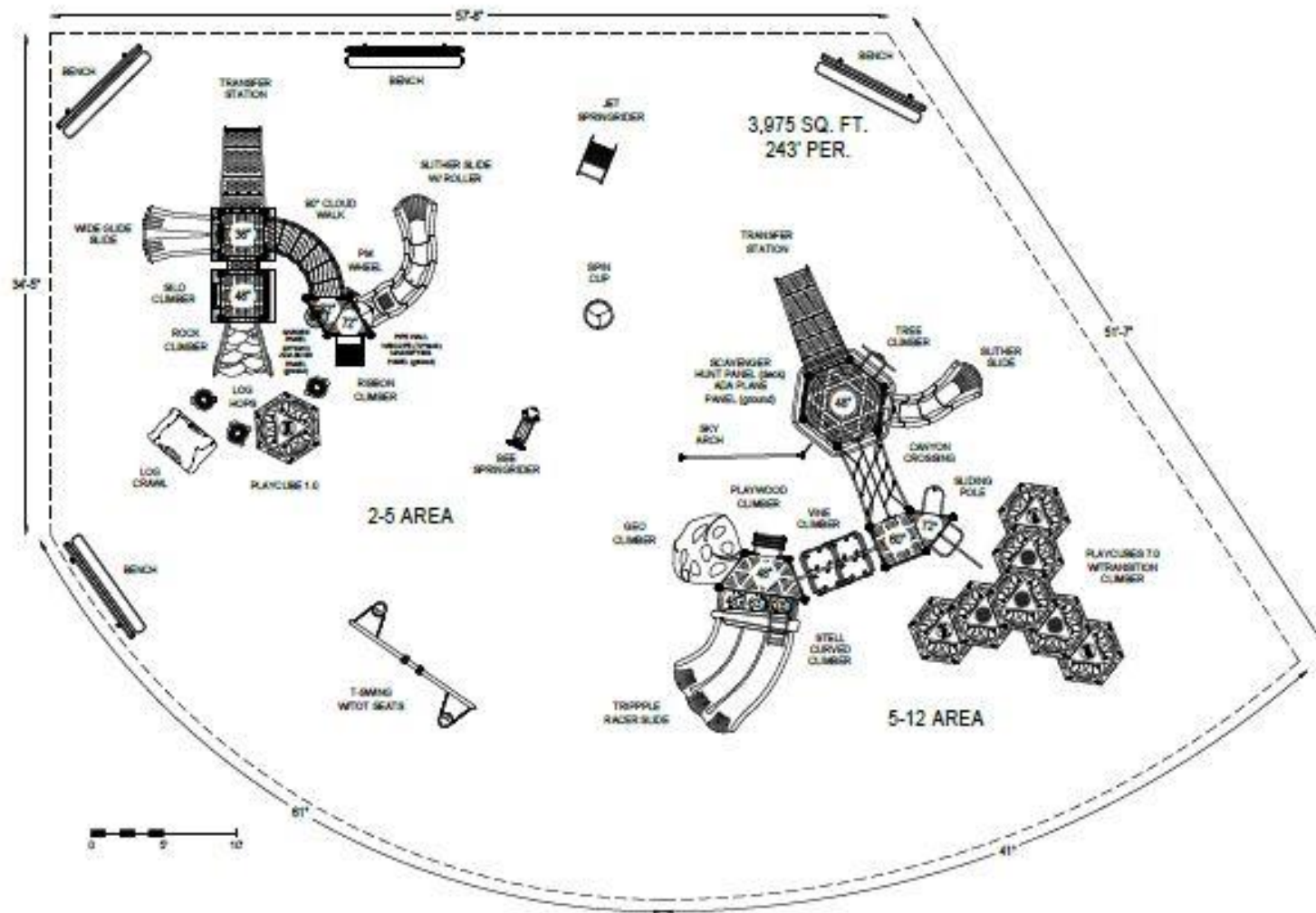


- Large structure for 2-5 year-olds

5-12 year-olds



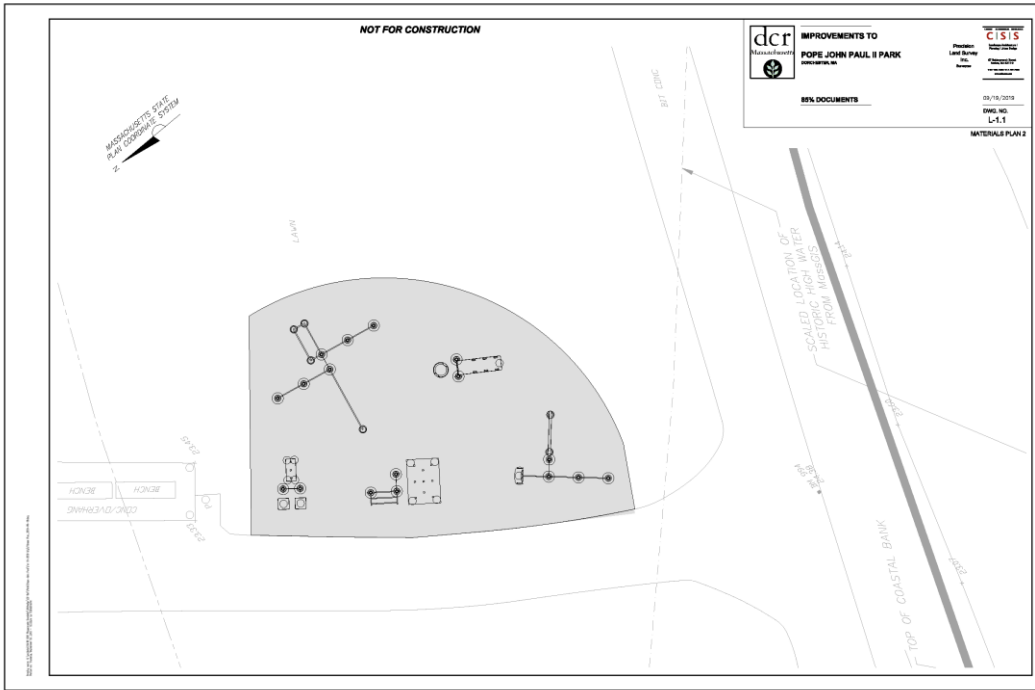
- Large structure for 5-12 year-olds

Anticipated Project Schedule

- Playground closed; temporary fence and project sign were installed fall 2019.
- Removal of existing playground equipment to be completed December 2019.
- Construction to begin in spring 2020.
- Playground & fitness equipment to open summer 2020.

- Access to Pope John Paul II Park will remain open.
