



This annual report provides information on pregnant women admitted to BSAS funded and/or licensed services. In FY 2017, there were 722 admissions where the client reported being pregnant at the time of admission. Starting in FY 2017, this fact sheet includes all age groups (including <18 years of age). To ensure proper interpretation of this data, please read the footnotes and refer to the appendix at the end of this report.

Characteristics of Admissions

- The average age at admission for pregnant women was 28.4 years.

- 42.3% had children under six years of age; 40.6% had children 6-18 years old.

- 9.1% lived with children under six years of age; 8.4% lived with children 6-18 years old.
