## New Waste Disposal Bans

- Final Regulations filed on 10/15/21 will be published on 10/29/21
- Effective date of new bans will be November 1, 2022
- Will include mattresses, textiles and reduced food waste threshold (from 1 ton to ½ ton per week)
- Changed definitions for mattresses and textiles to clarify that ban only applies to clean materials
- Will follow up with additional outreach and assistance to key stakeholder groups
  - Municipalities, businesses and institutions, service providers

# Implement New Waste Disposal Bans

- Guidance will be posted by end of this week
  - Facilities must submit revised plan at least 90 days before effective date
  - Encourage to submit sooner if coming in for other changes
- Factsheets and other educational materials will be updated soon
- Will be preparing FAQ on new waste ban materials over coming weeks
- Will continue to conduct outreach to key sectors
- RecyclingWorks in Massachusetts assistance

## **Update Organics Action Plan**

- Organics Subcommittee Meeting on 11/8/2021
- Will update Action Plan to support:
  - achieving SWMP goal of 500,000 tons additional food waste reduction by 2030
  - Implementing reduced waste ban threshold
- Will also address any additional Q&A related to reduced food waste ban threshold

# Publish Revised Reduce & Reuse Action Plan

- Developed through R&R Workgroup
- Received additional feedback on Draft Plan in summer
   2021
- Revised plan currently under final review at MassDEP
- Will hold workgroup meeting once Revised Plan completed and available

# Recycling Business Development Grants

- Grant program for recycling businesses handling specified target materials
- Grant awards beginning at \$50,000 and up to \$400,000
- Expect next application to be posted in November with applications due in Spring 2022
- Target materials will include new waste ban materials
- Will send announcement to our advisory committee lists and interested businesses once posted

# Recycling Market Development Workgroup

- Group will work with MassDEP to develop Recycling Market Development work plan
- Expect to hold first meeting in December 2021
- Will also provide input to MassDEP on new Recycling
   Waste Reduction Innovations Grant

# State Agency Recycling Market Development Council

- Inter-Agency Council headed by EEA and staffed by MassDEP
- Will include representatives from key state agencies including, but not limited to:
  - Division of Capital Assessment Management (DCAM)
  - Dept. of Transportation (MassDOT)
  - Operational Services Division (OSD)
  - Leading by Example program (DOER)
- Focus on supporting markets for target materials: asphalt shingles, tires, glass, office furniture, compost

## Recycling & Waste Reduction Innovations Grant

- New grant program application to be issued in 2022
- Focus on innovative waste reduction & recycling technologies and strategies
- Will be funded with initial \$1 million investment
- MassDEP will consult with Advisory Committees on best ways to structure and target these grants

# Draft Solid Waste Regulations Amendments

- MassDEP has conducted an internal review of the 310 CMR 16.00 and 19.000 regulations
- Have sought initial stakeholder input on pre-public hearing draft regulation amendments
- Expect to issue draft regulations for public comment and hearing in 2022

## C&D Minimum Performance Standard Goals and Objectives

Simply put...

## Ensure that every ton of C&D debris is processed at an MPS-compliant facility

- Level the playing field for all facilities
- Recover maximum value from recyclable/re-usable materials
- Separate all waste ban materials
- Minimize tonnage sent for disposal "Reduce Leakage"

#### C&D MPS Performance Criteria

- C&D MPS performance criteria:
  - 1. Achieve a 15% Process Separation Rate (PSR) minimum threshold;
  - 2. Demonstrate that all banned materials are separated to the greatest extent possible.
- Failure to satisfy either performance criterion constitutes a failure to comply with Waste Ban Regs and Waste Ban Compliance Plan
  - Cannot dispose or arrange for disposal of any C&D materials

Note: The MPS performance criteria are not applicable to a C&D Transfer Station that operates as follows:

- Transfers all C&D materials to an MPS-compliant facility for further processing
- Separates clean gypsum wallboard and Zero-Tolerance waste ban items prior to transfer

## Provisos for Conditionally MPS Compliant Facilities

- Must continue to comply with existing ATO Permit and Waste Ban Compliance Plan
  - May be subject to enforcement for failure to comply
- Monthly progress reports that fail to demonstrate MPS compliance must provide specific actions to improve operational performance

# Recycling Dividends Program Overview

- Provides payments to municipalities that implement specified reuse, recycling, and waste reduction programs and policies
- Payments based on a program point system & # households served
- Must be spent on qualified recycling & waste reduction program expenses
- Typical payments about \$3.2 million to about 225 municipalities

### **Small Scale Grants Overview**

- Small grants (\$500-2,000) for municipalities that do not receive RDP payments
- About 40-50 municipalities for about \$50,000
- No eligibility criteria

## **Program Changes for FY23**

- Eliminate small scale grants
  - except for qualifying regional groups
- Drop minimum number of RDP points to 1 point
  - Previously minimum point value was 8 points
- Municipalities with 10 or more points will earn full point value
  - If less than 10 points will earn a 70% point value
- Required to file recycling & SW survey, RDP annual report & Buy Recycled Policy notification on time
  - Will lose 1 point if late

### **Environmental Justice Criteria**

- Defined EJ municipalities can participate with no minimum point value and receive full payment per point
  - Municipalities (22) that meet all 3 EJ criteria and with more than 45% of residents living in EJ Census Block
- Added point for education and outreach to EJ populations

## Other Criteria Changes

- Tightened criteria for PAYT program points
- Added point option for municipally negotiated food waste collection program (but paid for by residents)
- Added multiple point options for reuse and reduction
- Increased points for hauler/mandatory recycling regulations that are adopted and enforced
