Goal 1: Protect and Steward Resilient Landscapes

Protect

Lead a public-private coalition to protect **30%** of Massachusetts by 2025 (vs. 27% now).

- To accomplish this goal, Mass Audubon will propel the conservation of an additional
 150,000 acres in partnership with government agencies, land trusts, and private landowners.
- Mass Audubon will protect 10,000 acres by 2025 as part of that total.

Steward

Restore and enhance the management of **200,000** acres of public and privately-owned forestland by applying wildlife-friendly and climate-smart forest management standards on those lands.

Restore and manage **2,500** acres of coastal ecosystems.



4 Strategies

1. Focus our land protection actions where it matters most.

- Map, prioritize, and preserve forests and coastal watershed ecosystems.
- Prioritize natural habitats for wildlife, carbon sequestration, clean air and water.

2. Accelerate the pace of land conservation.

- Catalyze a statewide coalition of public and private partners to protect more land.
- Execute land transactions in partnership with federal and state agencies.

3. Amplify our actions through advocacy.

Advocate for and advance policies and funding to support land conservation and restoration.

4. Strengthen management and stewardship of key habitats.

- Expand Foresters for the Birds and Climate Smart Forestry programs.
- Restore and manage coastal watershed ecosystems vulnerable to climate change.



Our commitment to inclusive and equitable access

Diversity, Equity, Inclusion, and Justice (DEIJ) are central to our mission and we will apply these principles in all of our work.


- Listen to diverse populations and work together to create inclusive access to our sanctuaries and programs.
- Build an internal culture of inclusivity and equity.
- Increase diversity of our board of directors and our staff.
- Include the stories of indigenous people and people of color in our programming.



Listen and Engage

- Protect and increase access to 20 urban greenspaces.
 - Of these, create 3 new Mass Audubon urban sanctuaries.
- Increase nature-based educational programming in lowincome communities and communities of color.
 - Grow engagement of children from low-income communities and communities of color from **35,000 to 90,000**.
- Double the total number of children impacted by Mass Audubon's programs from **150,000 to 300,000**.
- Establish \$2 million in scholarships for low-income families.

4 Strategies

1. Listen and build partnerships to identify urban greenspaces for protection, restoration, and access.

• Prioritize partnerships and green spaces that meet the needs of low-income communities and communities of color.

2. Create catalytic partnerships to green urban communities.

• Lead a statewide effort to listen to diverse constituents, local governments, and community partners, to create and implement a new urban greening initiative.

3. Expand and Deepen Environmental Education and Career Programs.

- Strengthen and expand statewide education programs.
- Launch the Environmental Fellows Program to provide early career opportunities for people of color at Mass Audubon.

4. Use the values of DEIJ to strengthen our organization

- Use DEIJ strategies to attract, retain, and engage our staff and Board members.
- Increase the diversity of our staff and Board.
- Continue to increase access at our sanctuaries, including building more All Persons Trails.



Mass Audubon is a national and international leader in creating All Persons Trails, which provide access to nature for all people, regardless of ability.



Goal 3: Mobilize to Fight Climate Change

Mobilize

- Educate and mobilize our 135,000 members to advance climate policies.
- Inspire and engage 1,000 adults, college students, and youth to become trained champions for climate and conservation policy.

Advocate

- Achieve full implementation of the state's net zero carbon emissions goal by 2050 with partners.
- Drive policies for nature-based climate solutions.
- Advance climate policies that reverse the negative health impacts of climate change for low-income communities and communities of color.



4 Strategies

- 1. Mobilize our members to become effective climate and conservation advocates.
 - Establish climate champion programs to engage high school, college, and adult populations to lead and advocate on behalf of climate policy.
- 2. Take the lead on advancing nature-based climate policy and solutions.
 - Advance policies to grow funding and expand markets to enhance forests, farms, and coastal ecosystems.
- 3. Support our partners in efforts to reduce emissions in the transportation sector and expand well-sited renewable energy.
- 4. Lead by example with carbon-reducing practices at our sanctuaries and facilities.






Youth from across the state participate in annual Youth Climate Summits hosted by Mass Audubon as part of the Youth Climate Leadership Program.
