Project Scope – Winthrop Shore Drive

- Improve sidewalks and install sidewalk amenities at major entrances
- Reconstruct roadway
- Improve drainage/storm water management
- Improve accessibility
- Enhance ocean side lighting
- Create new Beach Road Gateway
- Replace water main

Highlands Plan



- New landscaping
- Railroad pattern in pavers
- New concrete sidewalk
- Body/Foot shower

- Shade structure
- New benches, tables and chairs
- Replace railing and repair wall
- Bike racks



Construction Plan

- Work Hours:
 - 7:00 AM to 3:30 PM
 - Monday to Friday
- Expected Duration:
 - 2 years (finish June 2019)
- Work will start at Beacon Circle
- Start with underground piping; then curbing, sidewalks, paving
- Winthrop Highlands landscaping:
 Spring 2018
