


What is the Solid Waste Master Plan?

- ▶ Big picture plan for how we will manage our trash
- Updated on about 10 year planning cycles
- Current plan published in October 2021
- ▶ This plan runs through 2030

What are our waste reduction goals?

- ► Ensure adequate capacity to manage our waste
 - Our preferred option is to reduce the amount of waste disposed
- ▶ Reduce disposal by 30% by 2030
- ▶ Reduce disposal by 90% by 2050

What does MassDEP do?

- Regulations and policies
- Permitting
- ► Inspections, compliance and enforcement
- ▶ Grants and assistance
- ▶ Education and outreach

What does MassDEP not do?

- ▶ Develop, plan, or operate specific facilities or collection programs
 - ► Facilities and programs are run by the private sector or local governments
- Develop specific legislation
 - Our focus is to implement the state's laws under our authority

- More detailed and flexible Action Plans coupled with midway program review
- Subcommittees & Workgroups
 - Organics (food waste)
 - ▶ Construction & Demolition
 - Recycling Market Development
 - ▶ Reduce & Reuse

- Increased emphasis on reduce & reuse
 - Reduce & Reuse Action Plan https://www.mass.gov/servicedetails/massdep-reduce-reuserr-working-group
 - Reuse durable materials like furniture
 - Repair durable products like appliances
 - Share materials locally like power tools
 - Reduce material use single use packaging



- More engagement with and support of Environmental Justice communities
- ▶ Communities with either
 - ▶ Lower income,
 - ► Higher minority populations, or
 - ► Higher non-English speaking households

- Support of Environmental Justice Communities
 - ▶ Prioritize for grant awards
 - Assistance for composting at community gardens
 - ► Leverage MassDEP's Illegal Disposal Surveillance Program
 - ▶ Promote use of hybrid/electric trash & recycling collection trucks
 - Improved notice for facility permits

- Build local markets for our recyclables
 - Recycling Market
 Development Workgroup and
 Action Plan
 - State Agency Recycling Market Development Council
 - New \$1 million Innovations Grant Program



- New waste disposal bans
 - Mattresses and textiles
 - ▶ Increasing scope of food materials ban
 - ▶ Lowering threshold from 1 ton to ½ ton per week
- Minimum Performance Standard for Construction & Demolition Waste Facilities
 - Ensure level playing field
 - Increase separation of materials for recycling

Workgroup (WG) Goals and Schedule

Winter 2022

- ▶ Hold meetings January-March
- January Meeting-MA Focused
- February/March Meeting-Focused on region and other state programs
- Develop initial list of stakeholder program input and suggestions
- Receive input on Target Materials

WG Goals and Schedule

Spring/Summer 2022

- ▶ Hold 3 workgroup meetings by program category
 - ▶ (e.g., grants, education and outreach, regulations)
- Define Action Plan framework and strategies by program category
- ► List strategies as short term (1-2 years), medium term (3-5 years), or long term (6-10 years)
- ▶ Define target materials

WG Goals and Schedule

Fall 2022/Winter 2023

- ▶ Hold 2 workgroup meetings
- MassDEP prepare draft plan and obtain stakeholder feedback on draft plan
- MassDEP management review and approval of Action Plan
- Post Plan on MassDEP web site and present to stakeholders at WG meeting and at SWAC

WG Goals and Schedule

2023 and Beyond

- ►Implement plan
- Review and update plan as needed
- Report on progress annually to workgroup

RBDG

- Grant Awards between \$50,000 and \$400,000
- ► Awarded 28 grants for \$4.25 million
- ► Eligible Materials:
 - ▶ C&D Materials
 - ▶ Container Glass
 - ▶ Food Materials
 - ▶ Furniture
 - Mattresses
 - ▶ Textiles
- Evaluation Criteria includes whether applicant is registered as Certified Business in Commonwealth's Supplier Diversity Program
- ► Application deadline: April 8, 2022

Recycling Loan Fund

- Funded by MassDEP, administered under contract by BDC Capital
- ▶ Loans range from \$50,000 to \$500,000
- ► Loans up to \$1.5 million for anaerobic digestion projects
- ▶ Terms up to ten years
- ▶ Since 1996, 80 loans totaling > \$18 million

Waste Bans

- Certain recyclable and compostable materials banned from disposal or transfer for disposal
- First waste bans begin in early 1990s
- MassDEP conducts inspections at solid waste facilities, but enforces primarily against waste generators and haulers
- Implement as part of comprehensive approach including education, outreach, compliance assistance and market development
- Help to drive material supply to support recycling businesses.
- Encourage investment in recycling infrastructure in Mass

Waste Bans – Banned Materials

- Asphalt pavement, brick and concrete
- Cathode ray tubes
- Clean gypsum wallboard
- Commercial food material (lower threshold effective November 1, 2022)
- Ferrous and non-ferrous metals
- Glass and metal containers
- Lead acid batteries
- Leaves and yard waste
- Mattresses (effective November 1, 2022)
- Recyclable paper, cardboard and paperboard
- Single-resin narrow-necked plastic containers
- Textiles (effective November 1, 2022)
- Treated and untreated wood and wood waste (banned from landfills only)
- White goods (large appliances)
- Whole tires (banned from landfills only; shredded tires acceptable)

State Agency Recycling Market Development Council

- Chaired by Exec Office of Energy & Environmental Affairs
- First meeting to be held later this month
- ► Focus on increasing state agency purchasing of recycled content products
- ► Including, but not limited to, asphalt shingles, glass, compost, office furniture, and tires

- Regional Recycling Markets Committee
- Minimum Post-Consumer Recycled Content Model Legislation for Plastics
- ▶ Glass Committee
- ▶ Bottle Bill Committee


Municipal Recycling Grants

- Sustainable Materials Recovery Program Grants support collection/supply side of markets
- ▶ \$3.5 million per year for Recycling Dividends Program
- Investments in best practices and programs
- ▶ \$1 million per year for equipment/infrastructure
- Municipal Buy Recycled Policy and annual notification to purchasing officials
- Pre-requisite for municipal grants
- Demand side initiative

Mattress Recycling Investments

- State Contract for mattress recycling services
- ▶ Mattress Recycling Incentive Grant: 2016 to present
 - ▶ 96 municipalities awarded
 - ▶ \$2.3 million paid to mattress recyclers for processing
 - ▶ 18,000 mattresses
- Capital Equipment Grants to mattress recyclers
 - ▶ \$100,000 SMRP
 - ▶ 5 RBDG grants for \$800,000
 - ▶ Waste Ban on mattresses/box springs: Nov 1, 2022
