



Released On-Site and Transferred Off-Site for Treatment or Disposal Reporting Years 1990-2021 (includes trade secret data)




Production Ratio

The TURA reported production ratio is what we use in measuring progress, to account for changes in production.

Progress in Toxics Use Reduction 2007 Core Group

- Includes all industry categories and chemicals subject to reporting in 2007 and remained subject to reporting in 2021 at the same threshold
- Excludes trade secret chemicals and chemicals designated as higher hazard substances, and chemicals added through EPA TRI after 2007
- ► Includes 389 filers, which represents 90% of the 2021 TURA filers


2007 Core Group Progress in Toxics Use Reduction (2007-2021) Production Adjusted Total Use (Excludes Trade Secret Data)




Progress in Toxics Use Reduction 2000 Core Group

- Provides a longer history than the 2007 Core Group
- Includes 341 filers, which represents 79% of 2021 TURA filers
- Excludes trade secret data

2000 Core Group Progress in Toxics Use Reduction 2000-2021 Production Adjusted Total Use (Excludes Trade Secret Data)




2000 Core Group Progress in Toxics Use Reduction 2000-2021 Production Adjusted Byproduct (Excludes Trade Secret Data)




The 2021 top 20 chemicals accounted for:

- 93% of the total off-site transfers


2021 Number of Facilities by Industrial Sector Total Number of Facilities = 432 (Includes Trade Secret Data)








All Reported Data: 2021 Byproduct Generation by Industrial Sector Total Byproduct = 71,000,000 Pounds (Includes Trade Secret Data)


