## **DECISION**

Jill F. Zelley dba Mountainside Market (the "Licensee") holds an all-alcoholic beverages license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, March 13, 2012, regarding an alleged violation of M.G.L. c. 138, §34. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Brad Doyle's Compliance Check Field Report.

## **FACTS**

- On Saturday, September 24, 2011, at approximately 2:42 p.m., Investigators Jan Kujawski and Brad Doyle conducted an investigation of the business operation of Jill F. Zelley dba Mountainside Market.
- 2. An underage operative working with investigators purchased an alcoholic beverage, a six (6) pack of Heineken beer, for nine dollars and fifty cents (\$9.50). The underage operative was not asked for identification.
