IBC 2021 CHAPTER 17 SPECIAL INSPECTIONS AND TESTS

SECTION 1703 APPROVALS

Add new language as follows:

1703.1.3 Personnel. An approved agency shall employ experienced personnel educated in conducting, supervising, and evaluating tests and special inspections.

1703.1.3.1 Concrete Testing Personnel. Individuals with current credentials as provided in Table 1704.2 or equivalent credentials approved by the building official, shall be considered qualified for sampling and testing of concrete.

SECTION 1704 SPECIAL INSPECTIONS AND TESTS, CONTRACTOR RESPONSIBILITY AND STRUCTURAL OBSERVATIONS

Add new language as follows:

1704.2.1 Special inspector qualifications. Prior to the start of the construction, the *approved agencies* shall provide written documentation to the building official demonstrating the competence and relevant experience or training of the special inspectors who will perform the special inspections and tests during construction. Experience or training shall be considered relevant when the documented experience or training is related in complexity to the same type of *special inspection* activities for projects of similar complexity and material qualities. *The special inspector shall be qualified in accordance with Table 1704.2.* These qualifications are in addition to qualifications specified in other sections of this code.

The *registered design professional in responsible charge* and engineers of record involved in the design of the project are permitted to act as the *approved agency* and their personnel are permitted to act as the special inspector for the work designed by them, provided they qualify as special inspectors.

Background and rationale - This proposal addresses the need to better ensure proper sampling, testing, and inspection of structural elements. Improper testing and inspection may result in deficiencies regarding the performance of structural concrete. This is especially a concern for concrete, as it is one of the few structural materials that are not in their final form and condition until after being placed on the construction site. It is important that qualified individuals conduct sampling, testing, and inspection to ensure proper performance.

Improper sampling and testing can lead to costly added testing and construction delays. In some instances, unnecessary removal and replacement of concrete. The latter may result in challenges to ensure proper structural integrity and load paths.

This proposal is modelled after modification adopted by other authorities having jurisdiction to include requirements for various building materials and systems. The Georgia Building Code now includes a table of minimum qualifications for certified inspectors. See pages 10 through 12 of the attached file, <u>IBC_2020_amendments.pdf</u>. These amendments to add personnel qualifications were introduced in the Georgia Building code by members of the Structural Engineers Association of Georgia, circa 1996, and have proven to be a valuable tool for the building officials and all parties involved in or impacted by inspection and testing.

Benefits (Pros) – Enhanced confidence that concrete will perform as anticipated. When results of tests or inspections are not properly representative of the performance of the concrete, this could lead to huge delays and cost. Direct costs may be additional tests, taking and testing cores, or rejection and removal and replacement of the concrete. All of these could also have indirect costs due to construction delays. This proposal identifies personnel qualified to conduct inspections and tests to aid and better ensure the public, building official, owners, designers, contractors, and material suppliers that tests and inspections are conducted properly and are representative of the intended performance of structural concrete elements.

Challenges (Cons) - None. Tests and inspections are already required, but need assurance that individuals are qualified to conduct sampling testing and inspections

Estimated impact on life safety – This code change proposal will assist the building official in the determination of qualifications of individuals conducting sampling, testing and inspection of construction materials, including structural concrete. When these duties are performed by qualified personnel, there is greater assurance the minimum qualifications of the code will be met, thus having a positive impact on life safety.

Estimated Cost Impact - The code change proposal will not increase or decrease the cost of construction. This proposal increases the ease for the building official to determine the qualifications of individuals qualified to conduct sampling, testing and inspection of structural concrete.
