

Project Location

Interstate 90 in Sturbridge/Charlton/Oxford/Auburn (MM 78.3 to MM 88.3)



- Lane shifting will be required but will maintain one lane in each direction.
- Nighttime operation requires 5-hr day w/ 5-day week. Work conducted btwn approved hrs of 9PM & 5AM unless otherwise authorized by the Engineer & w/ certain holiday exceptions.
- Construction will take approx. two years from NTP.



Overview

Scope of Services/Purpose & Need

- Scope of Services
- Resurfacing a portion on Interstate 90 through Sturbridge, Charlton, Oxford, and Auburn from MM 78.3 to MM 88.3
- Work primarily consists of milling and paving the mainline, ramps, bridge decks, and transitions to and from bridge decks.
- Related work includes bridge improvements; stormwater improvements; clearing and grubbing; adjusting and rebuilding existing drainage structures; replacing damaged frames and grates/covers; resetting granite edging; replacing hot mix asphalt berm; replacing existing substandard guardrail; placement of recessed polyurea pavement markings, preformed tape, and recessed reflectors.
- Purpose & Need
- Existing pavement has degraded to a poor level and requires resurfacing. Resurfacing will improve the pavement serviceability, condition, and roadway safety.
- Superstructures of bridges have deteriorated and require routine maintenance work.

Project Advertised July 29, 2023

• Engineer's Estimate was \$31,607,819.40

• This project was originally advertised on January 28, 2023 with an Engineer's Estimate of \$29,290,288.00. Based on bids received at that time being over 40% higher than the Engineer's Estimate, MassDOT determined that the best course of action was to reject the bids, revise the scope of work and the estimate then re-advertise the project in July 2023.

• Staff request that the MassDOT Board authorize the Secretary of the Massachusetts Department of Transportation, or their designee, to award and execute MassDOT Construction Contract 123407 – Interstate Maintenance and Related Work on I-90 with JH Lynch & Sons Inc. in the amount of \$33,288,892.20.
